ORDER**Sub: - Grant of Dearness Relief to AVVNL Pensioners.**


In exercise of powers conferred vide order No. AVVNL/CAO (R&C)/AAO(Rule)/F-15/OO/ D. 3416 dated 05.12.2011, (AVVNL-Rule-527) the Managing Director, AVVNL is pleased to adopt the State Government's order No. F.12(8)/FD(Rules)/2017 dated 27.03.2020 (copy enclosed) issued by the Finance Department, GoR regarding grant of Dearness Relief to State Government Pensioners for application in respect of pensioners of AVVNL from 12% to 17% w.e.f. 01.07.2019. Accordingly, the existing rate of Dearness Relief payable to the Pensioners, as allowed vide order No. No. AVVNL/CAO(ERB)/AAO(Rule)/F.4/OO/D.4082 Dated 02.03.2019 (AVVNL-Rule-864) shall be revised from 12% to 17% w.e.f. 01.07.2019.

The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to next higher rupee. The provisions of this order shall also be applicable to the pensioners of erstwhile RSEB.

The amount of Dearness Relief at increased rate for the month of March, 2020 and onwards shall be paid alongwith pension for respective month and the arrears of increased Dearness Relief i.e. 12% to 17% for the period from 01.07.2019 to 29.02.2020 will be arranged/released in one installment with the pension for the month of April, 2020 payable in May, 2020.


