ORDER

In exercise of the power conferred vide order no. AVVNL/CAO (R&C)/AAO (Rule)/F-15/OO/D-3416 dated 05.12.2011 (AVVNL-Rule-527) the Managing Director, AVVNL is pleased to adopt the GoR's Notification No. F.7(1) DOP/ A-II/95/Pt.-II dated 18.08.2020 issued by the Department of Personnel (A-Gr.II), GoR and the existiting following last proviso to sub-regulation (4) of regulation as mentioned in column No. 3, against each of Service Regulations as mentioned in column no. 2 of the table given below:-

“Provided also that any person who performed remarriage which is not against any law and before such remarriage he is not disqualified for promotion under this sub-regulation, shall not be disqualified if any child is born out of single delivery from such remarriage.”

Shall be substituted by the following, namely:-

“Provided also that any person who performed remarriage which is not against any law and before such remarriage he is not disqualified for promotion under this sub-regulation, he shall not be deemed to be disqualified, if any child is born out of single delivery from such remarriage.”


