## ORDER

Sub:- Amendment in the AVVNL Various Service Regulations.

The Coordination Committee of Rajasthan State Power Sector Companies, in its 26<sup>th</sup> Meeting held on 30<sup>th</sup> December, 2020, has recommended to adopt the notification No. F.7(1)DOP/A-II/95/Pt-II dated 18.08.2020 issued by the Department of Personnel, GoR and to make necessary amendments in Various Services Regulations and Guidelines for DPC, 2017 namely:-

- (1) In the guidelines for promotions issued vide order no AVVNL / CAO(ETB) / AAO(Rule) / F.102 / OO / D.1530 dated 06.07.2017 (AVVNL-Rule-755) following amendments shall be made; namely:-
  - (a) The expression 'पाँच भर्ती वर्ष'' as appearing in clause no. 10.5 of Part-I, shall be substituted by ''तीन भर्ती वर्ष''.
  - (b) The existing clause no. 10.5 (v) of Part-I, shall be substituted by the following:-

"यदि कोई व्यक्ति पुनर्विवाह करता है, जो किसी भी विधि के विरुद्ध नहीं है एवं ऐसे पुनर्विवाह से पूर्व, वह इस उप-विनियम में पदोन्निति के लिए अयोग्य नहीं है, तो वह पदौन्निति के लिए 01.11.2007 से अयोग्य नहीं माना जाएगा यदि इस पुनर्विवाह से एकल प्रसव से कोई संतान उत्पन्न होती है।"

(2) Such amendments in Various Services Regulations have already been done vide Nigam's order No. AVVNL/CAO(ECR)/F.18/OO/D.2935 Dt. 02.11.2020 (AVVNL-Rule-935).
