ORDER

Consequent upon approval of the Energy Department, GoR conveyed vide letter No. F. 4(37) Energy/2017 pt. I dated 09.04.2021 for allowing relaxation to EWS class candidates in Fees & age equivalent to candidates of other reserved category in direct recruitment, the Managing Director, AVVNL in consultation with Director (Finance), AVVNL is pleased to order that following amendments are hereby made in various service regulations of AVVN, namely:-

- (1) The existing proviso number (i) of the regulation mentioned in column number 3 against each of the Service Regulations mentioned in column number 2 of the 'Table' given below, shall be substituted by the following new provision, namely:-
 - (i) the upper age limit mentioned above shall be relaxed by :
 - (a) 5 years in the case of male candidates belonging to the Scheduled Castes, Scheduled Tribes, Backward Classes, More Backward Classes and Economically Weaker Sections;
 - (b) 5 years in the case of woman candidates belonging to General Category; and
 - (c) 10 years in the case of woman candidates belonging to the Scheduled Castes, Scheduled Tribes, Backward Classes, More Backward Classes and Economically Weaker Sections.

- (2) The existing proviso number (ii) below Regulation 4 (D) (1) of Technical Workmen Service Regulation, shall be substituted by the following new provision, namely:-
 - (ii) That the upper age limit mentioned in Schedule-III shall be relaxed by :
 - (a) 5 years in the case of male candidates belonging to the Scheduled Castes, Scheduled Tribes, Backward Classes, More Backward Classes and Economically Weaker Sections;
 - (b) 5 years in the case of woman candidates belonging to General Category; and

(c) 10 years in the case of woman candidates belonging to the Scheduled Castes. Scheduled Tribes, Backward Classes, More Backward Classes and Economically Weaker Sections.

However, in respect of Ex-Servicemen, maximum age limit shall be 50 years.
