**A. AMENDMENT IN PROCEDURE FOR RECRUITMENT**

“the words “5% relaxation in marks shall be allowed to reserved category candidates” appearing against the name of Commercial Assistant-I/II in the column No.3 of table below clause (i) under heading “Qualification, Pay Scale & Mode of Recruitment” in Annexure- ‘A’ be substituted by the words “5% relaxation in marks shall be allowed to OBC/BC/SBC candidates and 10% to SC/ST/PH candidates.”


**B. MINISTERIAL STAFF REGULATIONS,1962**

The following amendment is hereby made in the Regulation No. 10(12) of Ministerial Staff Regulations, 1962, namely:-

“Reg. 10(12)- the words “5% relaxation in marks shall be admissible to candidates of reserved categories” appearing in regulation 10(12) be substituted by the words “5% relaxation in marks shall be admissible to OBC/BC/SBC candidates and 10% to SC/ST/PH candidates.”
