ORDER

Sub: Amendment in Ajmer Discom's various Service Regulations.

The following amendments are hereby made in the Ajmer Discom's Various Service Regulations viz. Engineer Service (Recruitment, Promotion And Seniority) Regulations, 1969, Officers Service (Recruitment, Promotion And Seniority) Regulations, 1974, Ministerial Staff Regulations, 1962, Technical Workmen Service Regulations, 1975 and Employees Service Regulations, 1975: -

(A) Engineer Service (Recruitment, Promotion And Seniority) Regulations, 1969: -

- 1) The word "and one year in the case of promotion" appearing in existing Sub-regulation (1) of Regulation 28 be deleted.
- 2) The existing Sub-regulation (3) of Regulation 28 be deleted.

(B) Officer's Service (Recruitment, Promotion And Seniority) Regulations, 1974: -

The word "and one year in the case of promotion" appearing after the words "two years" in Regulation 27 be deleted.

(C) Ministerial Staff Regulations, 1962: -

The word "and one year in the case of promotion" appearing in Sub-regulation (1) of Regulation 21 be deleted.

(D) Technical Workmen Service Regulations, 1975: -

- 1) The words "and those appointed by promotion/special selection to any post against the vacancy shall be on probation for a period of one year" appearing in Regulation 4(J)(i) be deleted.
- 2) The words "both for those appointed by direct recruitment or by promotion/special selection" appearing in Regulation 4(J)(iii) be deleted.
- 3) The word "and one year in the case of promotion" appearing in Sub-regulation (ii) of Regulation 5 be deleted.



- 2) The existing Regulation 7 be deleted.


This will be effective from 01.04.2015 and is subject to ratification by the Board of Directors.
