## ORDER

Sub :- Amendment in respect of definition of dependent children in the Rajasthan Civil Services (Medical Attendance) Rules, 2008.

Pursuant to the Co-ordination Committee decision taken in its 159<sup>th</sup> meeting held an 14.09.2012, it is hereby to adopt the Finance Department, GoR's Notification No. F.6(4) FD(Rules)/03 dated 23.03.2012 vide which following new explanation No.(v), has been inserted, below existing explanation No.(iv) of sub rule (10) of Rule 3 of Rajasthan Civil Services (Medical Attendance) Rules, 2008, namely:-

"Explanation No. (v)- For the purpose of this clause dependent children shall mean and include:-

(i)	Son	Till starts earning or gets married or attaining the age of 25 years, whichever is earlier.
(ii)	Daughter	Till starts earning or gets married, irrespective of the age limit, whichever is earlier.
(iii)	Son suffering from any permanent disability of any kind (physical or mental)	Irrespective of age limit."
