**ORDER-168**

**Sub:- Grant of Dearness Allowance to AVVNL employees.**

1. In exercise of the powers conferred vide order No. AVVNL / CAO / Rules / F. 1 (13) / D. 505 dated 03.11.2001, the Managing Director, AVVNL, Ajmer has been pleased to adopt the State Government's order No. F. 7 (1) FD (Rules) / 98 dated 27.01.2006. Accordingly, the existing rate of Dearness Allowance, payable to the employees, vide this office order No. AVVNL / CAO / AAO (Rules) / F. 1 (3) /D.967 dated 18.06.05 (Order No. 145) shall be revised w.e.f. 01.07.2005, as under:-

- i) Out of 61% D.A. sanctioned vide this office order No. AVVNL / CAO / AAO (F & R) / F. 1(3) /D. 2584 dated 03.12.04, 50% has been treated as Dearness Pay w.e.f. 01.07.2004 and remaining 11% of D.A. shall be admissible on Basic Pay as per order No. AVVNL / CAO / Rules / F & R / F. 1 (3 / 4)/D. 900 Ajmer dated 21.06.2004.
- ii) D.A. @ 10% w.e.f. 01.07.2005 shall be admissible on total of Basic Pay plus Dearness Pay.

The terms "Basic Pay" for the purpose of calculation of Dearness Allowance shall be the pay as defined in Regulation 3(xviii) (a) of Employees Service Regulations drawn in the Revised of pay Scale prescribed vide erstwhile RSEB's Order No. RSEB / F & R/ F. 46 (21) (iii) / D. 11 dated 24.02.1998, as amended from time to time, and shall not include any other type(s) of pay like special pay or personal pay, etc. In case of those employees who opt to retain the existing scale of pay, it will include in addition to pay in the pre-revised scale, dearness allowance and interim relief appropriate to that pay admissible under orders in existence on 01.01.1996.

2. The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.

3. The amount of increased D.A. and its arrears will be paid as follows:-

- (i) The existing rate of Dearness Allowance may be increased from 67% to 71%, w.e.f. 01.07.2005 and it shall be payable in cash w.e.f. 01.07.2005 i.e. salary for the month of February, 2006 payable on 01.03.2006.


(ii) The arrears of increased Dearness Allowance i.e. 67% to 71% for the period from 01.07.2005 to 31.01.2006 be paid to the employees in the following manner:-

- a. The arrears of increased Dearness Allowance may be paid in three equal installments alongwith salaries for the month of March, April and May 2006 payable in the month of April, May & June 2006 respectively.
- b. The Payment of DA at increased rates for the month of February 2006 and onwards shall be paid in cash alongwith respective month's salary.

4. The payment of Dearness Allowance/ D.A. arrear will also be subject to the terms and conditions laid down in the Rules for drawl of Dearness Allowance given in Appendix XVI of the R.S.R. Volume -II.

5. The increased D.A. shall also be admissible and paid in cash to those employees who were in service on or after 1.7.2005 but cease to be in service prior to the issue of this order, whether for disciplinary reasons or on account of resignation, retirement, death or discharge or abolition of sanctioned post.
