The Board of Directors in its 89th meeting held on 28th March - 2006, has accorded approval to add a new clause 1.42.5 (v) in General Conditions of Contract with corresponding change in Purchase Manual as follows:-

"A supplier who has successfully, executed three orders of any item in last ten years either in erstwhile RSEB or three Discoms or RVPN shall be treated as an old and established supplier provided that at least one of the three orders executed shall be of the item(s) for which the tender bid has been called for and the value of the order so executed is not less than the estimated value / implication involved in the tender bid."

The above amendment would be effective prospectively and applicable on future tenders only.
