ORDER - 185

Sub:- Modification in the purchase procedure for Discoms and amendment in the Purchase Manual.

The Board of Directors in its 93rd meeting held on 24.06.2006, has approved modifications in the purchase procedure of the Nigam and amendment in the Purchase Manual to the following extent:-

- (i) Requirement of annual turnover, quantity manufactured and minimum quantity to be offered and amount of Bank Guarantee to be furnished in absence of test certificate be reduced to 25% for Rajasthan based units.
- (ii) New State units and also those units located in Rajasthan which do not meet the qualifying criteria as above, may be considered for trial order within overall limit of 10% of the tendered quantity after assessment of their capability to manufacture and supply the quoted item.
- (iii) The words "20 firms" appearing in Para No. 10.2 (iii) of the Purchase Manual for the purpose of extending counter offer in case of distribution transformers of rating 40 KVA and below, LT cables and conductors may be substituted by "30 firms".
- (iv) Rajasthan based transformers suppliers shall be given 90 days period from the date of intimation for repair of the transformers failed within guarantee period. However, if they fail to do so, penalty will be levied after expiry of 90 days as per provisions of specification. Further, in case the transformers are not delivered duly repaired within 120 days from the date of intimation, then the cost of such transformers shall be deducted from financial held of the firm.
- (v) Amendments as at (i) to (iv) shall be applicable on purchase of all items.

The Board of Directors has also accorded approval for the following:-

- (i) The type test conducted at Govt. approved labs shall also be considered valid as is being done in RVPN.

- (ii) The quantity manufactured and supplied for higher rating conductor may be considered against the qualification requirement for lower rating.
- (iii) LT ABC Cable and insulated Rabbit conductor may be considered with LT cables and conductors, as there is a separate criteria for extending counter offers and award of orders for distribution transformer of 40 KVA and below, LT cable and conductor.

The Board further noted that the above modifications are as an interim arrangement for the current year and the same would be reviewed at appropriate time for adoption for next year.
