ORDER-210

Sub:- Grant of Dearness Allowance to AVVNL employees.

1. The Co-ordination Committee in its 101st meeting held on 08.02.2007 has decided to adopt the State Government's order No. F. 7 (1) FD / Rule / 98 dated 31.01.2007. Accordingly, the existing rate of Dearness Allowance, payable to the employees, vide this office order No. AVVNL / CAO / AAO (F & R) / F. 1 (3) / D. 1573 dated 24.02.2007 (Order No. 209) shall be revised w.e.f. 01.12.2006, as under:-

- (i) Out of 61% D.A. sanctioned vide this office order No. AVVNL / CAO / AAO (F & R) / F. 1(3) / D. 2584 dated 03.12.04, 50% has been treated as Dearness Pay w.e.f. 01.07.2004 and remaining 11% of D.A. shall be admissible on Basic Pay as per order No. AVVNL / CAO / AAO (F & R) / F. 1 (3) / D. 900 dated 21.06.2004 is now admissible on basic pay and dearness pay.
- (ii) D.A. @ 18% as indicated in item No. 1 (ii) of this office order No. AVVNL / CAO / AAO (F & R) / F. 1 (3) / D. 1573 dated 24.02.2007 (Order No. 209) payable on both basis pay plus dearness pay is further revised to 29% w.e.f. 01.12.2006 DA @ 11% only on basis pay now stands merged in 29% DA on basic pay and dearness pay.

The terms "Basic Pay" for the purpose of calculation of Dearness Allowance shall be the pay as defined in Regulation 3(xviii) (a) of Employees Service Regulations drawn in the Revised pay Scale prescribed vide erstwhile RSEB's Order No. RSEB / F & R / F. 46 (21) (iii) / D. 11 dated 24.02.1998, as amended from time to time, and shall not include any other type(s) of pay like special pay or personal pay, etc. In case of those employees who opt to retain the existing scale of pay, it will include in addition to pay in the pre-revised scale, dearness allowance and interim relief appropriate to that pay admissible under orders in existence on 01.01.1996.

2. The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.

3. The amount of increased D.A. and its arrears will be paid as follows:-

- (i) The existing rate of Dearness Allowance @ 11% on basic pay has been merged in DA @ 18% w.e.f. 01.12.2006 and shall be payable in cash w.e.f. 01.02.2007 i.e. salary for the month of Feb 2007 payable on 01.03.2007.
- (ii) The arrears on account of merger of 11% DA on basic pay in the 29% DA on basic pay plus Dearness Pay w.e.f. 01.12.2006 to 31.01.2007 be paid to the employees in the following manner:-

- i. The arrears of increased Dearness Allowance may be paid in four equal installments alongwith salaries for the month of April, May, June and July 2007 payable in the month of May, June, July and August 2007 respectively.
 - ii. The Payment of DA at increased rates for the month of Feb, 2007 and onwards shall be paid in cash alongwith respective month's salary.
4. The payment of Dearness Allowance/ D.A. arrear will also be subject to the terms and conditions laid down in the Rules for drawl of Dearness Allowance given in Appendix XVI of the R.S.R. Volume -II.
5. The increased D.A. shall also be admissible and paid in cash to those employees who were in service on or after 01.12.2006 but ceased to be in service prior to the issue of this order, whether for disciplinary reasons or on account of resignation, retirement, death or discharge or abolition of sanctioned post.
