In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules (which) to amend the Rajasthan Medical Officers Fees Rules 1964.

1. These rules may be called the Rajasthan Medical Officers Fees, (Amendment) Rules 2007.
2. They shall come into force with immediate effect.
3. In the aforesaid rules the existing Schedule 5 shall be substituted by the following namely.

Notes: The rates of fees are inclusive of conveyance charges for visits within municipal limits. For journeys beyond municipal limits the patient will have to pay the actual transport charges.
