**ORDER-263**

**Sub:-** Grant of Dearness Allowance to the Employees.

In exercise of the powers conferred vide No. AVVNL/ CAO/ Rules/F-1(13)/D-505 dated 03.11.2001, the Chairman & Managing Director has been pleased to adopt the State Government's order No. F-7(1)/FD(Rules)98 dated 25.02.2008 and the existing rate of Dearness Allowance payable to the employees vide order No. AVVNL/CAO/AAO(F&R)/F.1(3)/D-1580 dated 22.08.2007 (Order No. 244) shall be revised w.e.f. 01.07.2007 as under:-


- (i) Out of 61% Dearness Allowance referred in the order No. AVVNL/CAO/ AAO(F&R)/ F.1(3)/D-2584 dated 03.12.2004, 50% has been treated as Dearness Pay w.e.f. 01.07.2004.
- (ii) Dearness Allowance @ 35% on Basic Pay and Dearness Pay from 01.01.2007 as indicated in the aforesaid order No. AVVNL/CAO/AAO(F&R)/F.1(3)/D-1580 dated 22.08.2007, is further revised to 41% w.e.f. 01.07.2007.
- (2) The term "Basic Pay" for the purpose of calculation of Dearness Allowance shall be the pay as defined in Regulation 3 (xviii) (a) of Employees Service Regulations drawn in the Revised Pay Scale prescribed vide erstwhile RSEB's Order No. RSEB/F&R/F.46(21)(iii)/D.11 dated 24.02.1998, as amended from time to time, and shall not include any other type (s) of pay like special pay or personal pay, etc. In case of those employees who are drawing pay in the existing scale of pay, it will include, in addition to pay in the pre-revised scale, Dearness Allowance and interim relief appropriate to that pay admissible under orders in existence on 01.01.1996.
- (3) The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.
- (4) The amount of increased Dearness Allowance and its arrears will be paid as follows:-
  - (i) The Dearness Allowance at increased rate i.e. from 35 to 41% (with an increase of 6% w.e.f. 01.07.2007) for March, 2008 (payable in April, 2008) and onwards shall be payable in cash alongwith respective month's salary.
  - (ii) The amount of arrears of Dearness Allowance for the period 01.07.2007 to 29.02.2008 (on account of increase in DA)

shall be paid as under:-

The arrears of increased Dearness Allowance may be paid in four equal installments alongwith salaries for the month of April, May, June & July 2008 (payable in the months of May, June, July & Aug, 2008 respectively.)

- (5) The payment of Dearness Allowance will also be subject for the terms and conditions laid down in the Rules for drawl of Dearness Allowance given in appendix XVI of the R.S.R. Vol.II.
- (6) The increased Dearness Allowance shall also be admissible and paid in cash to those employees who were in service on or after 01.07.2007 but ceased to be in services prior to the issue of this order, whether for disciplinary reasons or on account of resignation, retirement, death or discharge or abolition of sanctioned post.
