

ORDER-275

Sub:- Grant of Dearness Allowance to the Employees.


In exercise of the powers conferred vide No. AVVNL/ CAO/ Rules/F-1(13)/D-505 dated 03.11.2001, the Managing Director has been pleased to adopt the State Government's order No. F-7(1)/FD(Rules)98 dated 14.08.2008 and the existing rate of Dearness Allowance payable to the employees vide order No. AVVNL/ CAO/ AAO(F&R)/F.1(3)/D-5127 dated 04.03.2008 (Order No. 263) shall be revised w.e.f. 01.01.2008 as under:-

- (i) Out of 61% Dearness Allowance referred in the order No. AVVNL/CAO/ AAO(F&R)/ F.1(3)/D-2584 dated 03.12.2004, 50% has been treated as Dearness Pay w.e.f. 01.07.2004.
- (ii) Dearness Allowance @ 41% on Basic Pay and Dearness Pay from 01.07.2007 as indicated in the aforesaid order No. AVVNL/CAO/AAO(F&R)/F.1(3)/D-5127 dated 04.03.2008, is further revised to 47% w.e.f. 01.01.2008.
- (2) The term "Basic Pay" for the purpose of calculation of Dearness Allowance shall be the pay as defined in Regulation 3 (xviii) (a) of Employees Service Regulations drawn in the Revised Pay Scale prescribed vide erstwhile RSEB's Order No. RSEB/F&R/F.46(21)(iii)/D.11 dated 24.02.1998, as amended from time to time, and shall not include any other type (s) of pay like special pay or personal pay, etc. In case of those employees who are drawing pay in the existing scale of pay, it will include, in addition to pay in the pre-revised scale, Dearness Allowance and interim relief appropriate to that pay admissible under orders in existence on 01.01.1996.
- (3) The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.
- (4) The amount of increased Dearness Allowance and its arrears will be paid as follows:-
 - (i) The Dearness Allowance at increased rate i.e. 6% shall be added in the salary of August, 2008 (payable in September, 2008) and onwards.

AMENDMENT
