ORDER

The Co-ordination Committee in its 121st Meeting held on 26.08.2008 has decided to allow the following incentive scheme to the staff of concerned Sub-division/Division/Circle:-

- (i) 10% of the auction proceeds of the material as incentive would be given to the concerned Sub-division including staff of Division/Circle for giving the information and deposit of surplus scattered steel material lying at various sites. The aforesaid 10% incentive would be distributed as follows:-
 - (a) 5% to the concerned staff of Sub-division/Division/Circle giving the information.
 - (b) 5% to the concerned Sub-division for up-liftment of the material.
- (ii) 2% of the auction proceeds of material as incentive would be given to concerned Sub-division/Division/Circle for removal and deposit of non-scattered redundant lines. The amount of incentive would be incurred for up-liftment of the material. The redundancy of the lines would be declared by the sanctioning authority.
- (iii) The amount spent by the Sub-division on transformation of such material from site to store shall be deducted from the 5% /2% in cash amount admissible to the concerned staff.
- (iv) Name of staff members giving information about such material shall be maintained in the Sub-division in a separate register.
- (v) The Circle Superintending Engineer shall be empowered to sanction such incentive.
- (vi) Aforesaid incentive scheme would remain applicable for three months i.e. upto 30th November, 2008 and shall not be extended further.

The above order is issued subject to ratification of Board of Directors.

ORDER

Sub: - Revision of Pension/Family Pension who retired/died on or after 1.09 1988 but before 1.09.1996 and are in receipt of Pension/Family Pension less than 50%/30% respectively of the minimum of the revised pay scale in force as on 01.09.1996.

In exercise of the powers conferred vide order No. RVFN/ADMO/AS CC/F&R /D.205 dated 01.012.2001, the Chairman and Managing Director, RVFN, in consultation with the Director (F & A), has been pleased to adopt mutafis muta idis the manner/procedure contained in the Memorandum of Govt. of Rajasthan bearing No.F.15(1)FD(Rules)/99 (Pension 3/08) dated 22.05.2008, for revision of Pension/Family Pension w.e.f. 01.07.2008 for the Pensioners/ Family Pensioners of the Nigam.

Accordingly, in partial modification of erstwhile RSEB order No. RSEB/F&R/F.3(10) /D.67 dated 19.08.1998 and Nigam's order No. RVFN/AS/GAD/F&R/Pension/D.7 2 dated 06.09.2005, the consolidated pension treated as final 'Basic Pension' as on 01.09.1996 of pre -1996 pensioner shall not be less than 50% of the minimum pay in the revised pay scales introduced w.e.f. 01.09.1996 of the post last held by the pensioner, subject to the condition that the existing provisions in the rules governing qualifying service for grant of pension and minimum pension shall continue to be operative.

Similarly, final 'Basic Family Pension' of pre-1996 family pensioner shall not be less than 30% of the minimum pay in the revised pay scales introduced w.e.f. 01.09.1996 of the post last held by the pensioner/deceased Nigam employee, as the case may be subject to the condition that the existing provisions in the rules governing minimum family pension shall continue to be operative.

This order shall come into force w.e.f. 01.07.2008.

Procedure for revision of pension/family pension shall be as under:-

(i) Each pre-1996 pensioner/family pensioner who was in receipt of pension/family pension as on 01.07.2008 and if his/her pension/family pension is less than 50% / 30% respectively of the minimum of the revised pay scale introduced w.e.f. 01.09.1996 of the post last held at the time of retirement/death while in service, shall be required to apply for revision of his/her pension/family pension, as the case may be, in the form as at 'Annexure-A' in triplicate to the Asstt. Secretary (Pension), RVFN, Jaipur.

(ii) In case, where the pensioner/family pensioner was alive as on 01.07.2008 and died subsequently, his/her legal heir(s) is/are also entitled to arrears w.e.f. 01.07.2008 till the death of pensioner/family pensioner. For this purpose, legal heir(s) may also apply to the Asstt. Secretary (Pension), RVFN, Jaipur.

(iii) The Asstt. Secretary (Pension), RVFN, shall scrutinize the applications submitted in the prescribed form by the pensioner/family pensioner and obtain sanction from the authority concerned.
