ORDER**Sub:- Grant of Dearness Allowance to Nigam's employees.**

Pursuant to the decision taken by the Coordination Committee by circulation on dated 1.10.2008, the Managing Director, AVVNL in consultation with the Director (Finance), has been pleased to adopt mutatis mutandis, the Govt. of Rajasthan order No. F.6(1)FD(Rules)/2008 dated 12.09.2008 in the matter of grant of DA consequent upon promulgation of the Revised Pay Scales, 2008 w.e.f. 01.09.06. The Nigam's employees shall be allowed Dearness Allowance with the running pay bands and grade pay from the dates mentioned below at the following rates:-

Date from which Payable	Rate of Dearness Allowance
From 01.01.2007	6%
From 01.07.2007	9%
From 01.01.2008	12%
From 01.07.2008	16%


2. The payment of Dearness Allowance under this order from the dates 01.01.2007, 01.07.2007 and 01.01.2008 indicated above shall be made after adjusting the amount of Dearness Allowance already paid from time to time under existing orders.

3. The term 'Pay' for the purpose of calculation of Dearness Allowance shall be the Basic Pay i.e. total of pay in running pay band and grade pay drawn and shall not include any other type(s) of pay like Special Pay or Personal Pay etc.

4. The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.

This is subject to ratification by the Board of Directors.
