ORDER**Sub:- Amendment in the RSEB (Determination & Recovery of Rent of Residential Accommodation) Regulations – 1980.**

Pursuant to the decision taken by the Coordination Committee by circulation on dated 1.10.2008, the Managing Director, AVVNL in consultation with the Director (Finance), has been pleased to adopt, mutatis mutandis, the Govt. of Rajasthan order No. F.1(55)GA/II/77-Pt-I dated 12th September,2008. Accordingly following amendments in the RSEB (Determination & Recovery of Rent of residential Accommodation) Regulations – 1980 shall be made;

In the said Regulations:-

- (1) Sub-regulation 2 of Regulation 18 be substituted by the following:-
- (a) Unless otherwise explicitly provided in these regulations an employee of the Nigam, who is drawing salary under the revised pay scales effective from 1.9.2006 shall pay monthly rent according to the following rates w.e.f. 1.1.2007.

Sr.No.	Pay Slab based on Basic Pay i.e. total of Pay in Running Pay Band and Grade Pay	Rate of Rent
1.	Below Rs.13000/- per month	0.75% of the pay
2.	Rs.13000 and above but below 19000/- per month	1.5% of the pay
3.	Rs.19000 per month and above	2% of the pay

- (b) The Officers of All India Services and Central Govt. employees on deputation drawing pay in the revised pay scales effective from 1.1.2006 shall pay


monthly rent according to the rates applicable to the State Government servants who draw pay under the Rajasthan Civil Services (Revised Pay Scales) Rules, 2008.

- (c) In case of those employees who opt to retain the existing scale of pay the term pay will include, in addition to pay in the pre-revised scale and Dearness Allowance appropriate to that pay admissible under orders in existence on 1.9.2006.

Provided that Nigam's employees residing in the category of accommodation lower than the one to which they are entitled to shall not be required to pay rent more than the maximum amount of rent payable by an employee who is entitled to that lower category of accommodation.

This is subject to ratification by the Board of Directors.
