Consequent upon promulgation of the Rajasthan Civil Services (Revised Pay) Rules, 2008, the Governor is pleased to order that in para 1 of the Finance Department Order No. F.10(4)FD(Gr.2)/76 dated 13.03.1984 as amended vide order dated 18.08.1989 and 02.05.1998, the existing words and figures "@ 5% of their pay not exceeding Rs.200/- per month" shall be substituted by the words and figures "@ 3% of their basic pay not exceeding Rs.300/- per month".
