**ORDER****Sub:- Grant of Compensatory (City) Allowance to Nigam's employees.**

Pursuant to the decision taken by the Coordination Committee by circulation on dated 1.10.2008, the Managing Director, AVVNL in consultation with the Director (Finance), has been pleased to adopt for application in the AVVNL the GoR order No.F.6(2)FD(Rules)/08 dated 12.9.2008 (copy enclosed) w.e.f. 1.9.2008 amendment in the Compensatory (City) Allowance. Accordingly, the following amendments shall be made in the Compensatory (City) Allowance Rules, 1970, namely:

- (i) The existing Rules (iii) shall be substituted by the following:  
 " The Compensatory (City) Allowance to Nigam's employees referred to in sub-rule(1) of Rule 1 shall be granted at the following rates:

NOTE:-

- (i) Nigam's employees who are entitled to free boardings (or Messing Allowance) and free lodging as a condition of their appointment shall be entitled to receive allowance at 50% of the rates prescribed under these Rules.
- (ii) Nigam's employees who are availing of only one facility of free boarding (messing allowance) or lodging shall be entitled to receive the allowance at the full rates.

This order shall take effect from 1.9.2008.

**Subject :** Grant of Compensatory (City) Allowance to Government servants.

The Governor is pleased to order that the following amendment shall be made in the Compensatory (City) Allowance Rules, 1970, namely -

In the said rules - the existing Rule 3 shall be substituted by the following, namely -

"3. **Rate of Compensatory (City) Allowance :** The Compensatory (City) Allowance to Government servants referred to in sub-rule (1) of Rule 1, shall be granted at the following rates:-

S. No.	Basic Pay i.e. total of pay in the Running Pay Band and Grade Pay	Amount of CCA (Rs. per month)	
		Jaipur (UA)	Ajmer, Bikaner, Jodhpur and Kota
(i)	Employees drawing Basic Pay upto Rs.7000/-.	130.00	50.00
(ii)	Employees drawing Basic Pay above Rs.7000/- but upto Rs.10000/-.	190.00	70.00
(iii)	Employees drawing Basic Pay above Rs.10000/- but upto Rs.13000/-.	300.00	130.00
(iv)	Employees drawing Basic Pay above Rs.13000/-.	480.00	240.00

Note: 1. Government servants who are entitled to free boarding (or messing allowance) and free lodging as a condition of their appointment shall be entitled to receive the allowance @ 50% of the rates prescribed under this rule.

2. For the purpose of 'Note 1' Police personnel living in barracks of Police Lines/Police Stations in Ajmer, Bikaner, Jaipur, Jodhpur and Kota City shall not be considered to be availing of the facility of free lodging and therefore, such Police personnel shall be entitled to the allowance at full rates.
