## CLARIFICATION

To implement the decision of the Hon'ble S.B. of Rajasthan High Court, Jodhpur, order No. RVPN/AAO/F&R/F.31/D. 16 dated 10.05.2012 (F&R No. 796), was issued. Various queries in the matter have been received, regarding the pay scale to be allowed to class-IV employees, who are eligible to be considered for promotion to the post of LDC as per Regulation 6.1(i)(b) of the RSEB Ministerial Service Regulations, 1962, at the time of granting 1st selection grade.

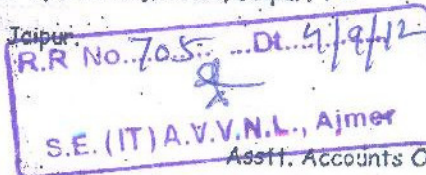
In this regard, it is clarified that 1<sup>st</sup> selection grade to the eligible Class-IV employees on completion of 9 years of service, is to be allowed in the pay scale of LDC prescribed in erstwhile RSEB/RVPN as on the date of granting 1<sup>st</sup> selection grade.
