ORDER

**Sub:- Grant of Dearness Allowance to AVVNL employees.**

(1) In exercise of the powers conferred vide order No. AVVNL/CAO/Rules/F./(13)/D-505 dated 03.11.2001 (Order-11), the Managing Director AVVNL, is pleased to adopt the State Government's order No. F. 6 (1) FD (Rules)/2008 dated 15.09.2011. Accordingly, the existing rate of Dearness Allowance payable to the employees, vide this office order No. AVVNL/ CAO (R&C)/Sr. AO(Rule)/F.3/D-6379 dated 28.03.2011 (AVVNL-Rule-473) shall be revised from 51% to 58% w.e.f. 01.07.2011.

(2) The term 'Pay' for the purpose of calculation of Dearness Allowance shall be the Basic Pay i.e. total of pay in running pay band and grade pay drawn and shall not include any other type(s) of pay like Special Pay or Personal Pay etc.

(3) The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.

(4) The amount of increase in Dearness Allowance i.e. 7% shall be added in the salary for the month of September, 2011 and onwards alongwith respective month's salary. Arrears of increased Dearness Allowance i.e. 51% to 58% for the period from 01.07.2011 to 31.08.2011 will be released / arranged in one installment with the salary of December, 2011 (payable in January, 2012).

(5) The increased Dearness Allowance shall also be admissible and paid in cash to those employees who were in service on or after 01.07.2011 but ceased to be in service prior to the issue of this order, whether for disciplinary reasons or on account of resignation, retirement, death or discharge or abolition of sanctioned post.
