ORDER

**Sub:- Grant of Dearness Relief to the Pensioners of AVVNL.**

(1) In exercise of the powers conferred vide order No. AVVNL/CAO/Rules/ F./(13)/D-505 dated 03.11.2001 (Order-11), the Managing Director AVVNL, is pleased to adopt the State Government's order No. F. 12(4)/FD (Rules)/2008 dated 15.09.2011 (copy enclosed) regarding grant of Dearness Relief to State Government Pensioners for application in respect of pensioners of AVVNL from 51% to 58% w.e.f. 01.07.2011. Accordingly, the existing rate of Dearness Relief payable to the pensioners, as mentioned in Annexure-'D' appended with this office order No. AVVNL/CAO/AAO(Rule)/F. RPS-08/ D. 3076 dated 01.10.2008 (AVVNL-Rule-293) shall be revised from 51% to 58% w.e.f. 01.07.2011.

(2) The provisions of this order shall also be applicable to the pensioners of erstwhile RSEB.

(3) The amount of Dearness Relief at increased rates for the month of September 2011 and onwards shall be paid alongwith pension for respective month.

(4) Further, the Managing Director, AVVNL, in consultation with Director(Finance) has also approved that the arrears of increased Dearness Relief i.e. 51% to 58% for the period from 01.07.2011 to 31.08.2011 will be arranged/released in one installment with the pension of December,2011 payable in January,2012.
