

GENERAL TERMS & CONDITIONS:-

- Tenderer must read the conditions carefully and comply strictly while submitting their tenders. No conditional tender shall be accepted, if found so, the undersigned reserves rights to reject the same without assigning any reason.
- Furnishing of Bid.
- One small size envelop containing proof of deposition/ furnishing the earnest money and vender registration certificate, this envelop shall be super scribed as “ Earnest Money Deposit”.
- One medium size envelop containing “ Price Bid” which shall be marked/super scribed as “ Price Bid”.
- And third big size envelop for containing above mentioned two envelops which shall be marked/super scribed as “ BID FOR TENDER NO 20/2016-17 TO BE OPENED ON 06.03.2017” and should be addressed to :-

- The tender should be addressed to the Superintending Engineer (ACC),AVVNL, Ajmer as explained in clause No.2 above.
- Tender form be filled in ink or typed. No tender filled in pencil shall be considered. The tenderer shall sign the tender form and each page of the tender specification also be signed in token of acceptance of all terms and conditions of the tender.
- The tenderer must mention his valid PAN Card Number in his tender.
- Rates be quoted both in words and figures. There should not be any errors /overwriting /corrections, if any should be made clearly and dated initials be appended.
- The earnest money @0.5% will have to be deposited by the registered contractor under Class E-I & E-II in cash/ through demand draft by the tenderer prior submitting the tender and proof of deposit of earnest money may be enclosed with the tender offer.
- The successful tenderer will have to furnish 2% security in the form of Bank Guarantee and performance Guarantee @5% in favour of the Superintending Engineer(ACC),AVVNL, Ajmer from any recognized Bank.
- The tenderer should be registered under Class E-I/II with the Chief Engineer(TW/Zonal Chief Engineer (A/Z) ,AVVNL, Ajmer and the tenderer should possess "A" class contractor ship license issued from the Senior Electrical Inspector, State Govt. of Rajasthan.
- The tender forms/specification can be purchased from this office after depositing tender fee Rs. 2500/- in cash /demand draft with the Accounts Officer (O&M), AVVNL, Ajmer by 06.03.2017 up to 2:30Pm.
- The quantity of supply/work may be vary (Increase/decrease) looking to work site conditions. The undersigned have the right to reject all the tenders without assigning any reason thereto.
- The material have to be supplied by the contractor should be ISI mark with copy of relevant ISS.
- No T&P shall be provided for laying of CI/HDPE pipe & 33 KV 300 sq mm XLPE cable under Railway track crossing and the work shall be carried out by the contractor as per AVVNL practice and tender specification. Proper case is to be taken up by the contractor for execution of work as per site conditions. In case of any dispute the Ajmer Discom's works Manual 2004 with the latest amendments shall be applicable and the decision of the Zonal Chief Engineer(A/Z),AVVNL, Ajmer will be final.
- The supply of CI Pipe / HDPE pipe will have to be made within 15 days & will have to be laid within 30 days after supply of CI Pipe / HDPE pipe in good conditions from the date of detailed work order.
- The material so supplied shall be inspected by the Executive Engineer (Const), AVVNL, Ajmer.
- The payment of composite bills for supply of material and execution of work shall be arranged by the Accounts Officer (O&M), AVVNL, Ajmer as per payment policy.
- Bidder must quote both rate & supply & laying of CI Pipe & HDPE pipe as per specification however AVVNL reserve the right to use any of one type of pipe
