**Sub:** Safety Consultant for 2 x 171.298 ckt km 400kV D/C Bikaner-Sikar Transmission Line Project developed on DBFOT basis for F.Y. 2021-22

RVPN has entered into a Transmission Agreement on dated 6.11.2015 with M/s KEC Bikaner Sikar Transmission Private Limited, presently known as M/s Adani Transmission Bikaner Sikar Private Limited (Concessionaire) for development of 400 kV D/C Bikaner - Sikar Transmission Line Project (2 x 171.298 ckt km) on DBFOT basis. Construction work of the project has been completed and the project has entered into commercial operation on 04<sup>th</sup> December'2017.

As per provisions of the Transmission Agreement, the Authority (RVPN) shall appoint an experienced and qualified firm or organisation (the "Safety Consultant") for carrying out safety audit of the Transmission System for securing compliance with the Safety Requirements. During the Operation Period of the project, the Safety Consultant shall review and analyse the annual report submitted by the Concessionaire and accident data of the preceding year, and undertake an inspection of the Transmission System. The Safety Consultant shall carry out Safety Audit and submit a Safety Report recommending specific improvements, if any, required to be made in the Transmission System.

The remuneration of the Safety Consultant, safety audit, and costs incidental thereto, shall be met by the Concessionaire.

Accordingly, it has been decided to designate your office to act as Safety Consultant of 400 kV D/C Bikaner - Sikar Transmission Line Project for the year 2021-22. M/s Adani Transmission Bikaner Sikar Private Limited (Concessionaire) shall pay the requisite fee directly to Electrical Inspectorate Department, GOR.

The role and responsibilities of the Safety Consultant, Safety Requirements and Safety Guidelines are scripted in Article 18 and Schedule-L of the Transmission Agreement. A copy of Transmission Agreement already has sent to your office vide this office letter No.741 dated 27.11.2020 .
