The Statutory Auditors of the company has carried out the Limited Review of the financial results for the Quarter and 9 Months ended as on 31st December, 2021 as required under Regulation 52 of the Securities and Exchange Board of India (Listing Obligations and disclosure Requirements) Regulation, 2015.
4. The Company has prepared the financial statements and financial results in compliance with Ind AS pursuant to the Notification of Ministry of Corporate Affairs (MCA) dated 16 February 2015.
5. In the absence of information, segment-wise details for the quarter ended as on 31st December 2021 and for the 9 Months ended 31st December 2021 are not given.

8. The bonds have been accredited with 'BWR A-(CE)' rating from Brickwork Ratings India Private Limited. There is no change in the credit rating.
9. The Bonds issued by the company are unsecured and are backed by unconditional Guarantee by Government of Rajasthan and accordingly requirement for disclosure and certification of asset cover is not applicable.
10. Government of India through Taxation Laws (Amendment) Ordinance, 2019, has inserted Section 115BAA of the Income Tax Act,1961 where by company has an irrevocable option of shifting to a lower tax rate along with consequent reduction in certain tax incentives including lapse of the accumulated MAT Credit. The company continues to recognise the taxes on income for the 9 Months ended as on 31st December 2021 as per the earlier provisions.



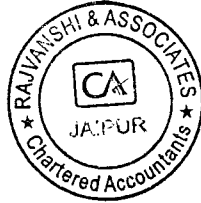
