

TERMS & CONDITIONS

6. The validity of the bidding rates shall be at least 30 days from the opening of bids.
7. All the bid documents shall have sign & seal of the bidder.
8. The bid security amounting to Rs. 3500/- will be deposited/furnished by the bidders as per Rule No. 42 of RTPP Rules, 2013 in favour of Sr. Accounts Officer(EA-Cash), RVPN, Jaipur.
9. The performance security will be deposited/furnished by successful bidder as per Rule No. 75 of RTPP Rules, 2013 i.e. @5% of the amount of supply order and it shall remain valid for a period of 60 days beyond the date of completion of all contractual

obligations of the bidder including warranty obligations, maintenance and defect liability period.
