Circular dated 15.07.2015 as per details given below:-

The Rates as per circular are as follows:-

1. For First 1500 Kms or Less, 20,000/- per month (Service tax extra if applicable)
2. For addition running of vehicle(more than 1500 KMs) the rate payable @Rs. 7.25 per KM.
3. Hired vehicles shall be used anywhere as per jurisdiction of the office where deployed. In case of night halt other than that of head quarter a sum of Rs. 200 per night shall be paid for the driver.
4. The maximum ceiling of Rs. 23625/- per month (Service tax extra if applicable) for 2000 Kms for offices having a district as their jurisdiction.
5. All taxes except toll tax shall be borne by the individual / contractor/firm.
6. Reimbursement of toll tax paid by the individual/contractor/firm shall be made on production of receipt of payments of toll tax.

Other Conditions shall be as under:-

1. Vehicle shall not be more than 6 years old. Only vehicle with taxi permit having valid documents like taxi permit, insurance, fitness, registration, pollution certificate etc shall be considered.
2. The vehicle is to be hired from 01.04.2017 to 31.03.2018 (12 Months). Bill is to be submitted monthly and payment shall be arranged on monthly basis. The rates/prices are firm inclusive of all taxes, duties R&M, Contribution to CPF/EPF/ESI & other liabilities except service Tax Charges if Applicable.
