

The Rates, Terms & Condition as per circular are as follow:

1. For the first 1500KM or less, Rs.20,000/. Per month (Service Tax extra if applicable).
2. For additional running of vehicle (more than 1500 KM), the rates shall be payable @ Rs. 7.25 per KM.
3. Hired vehicle shall be used anywhere as per jurisdiction of respective offices where deployed. In case of night halt other than of the head quarter a sum of Rs. 200/- per night i.e. shall be paid for driver.
4. The maximum ceiling of Rs. 23625/- per month (Service Tax extra if applicable) for 2000 KM for offices having a district as their jurisdiction.
5. All Taxes except Toll Tax shall be borne by the individual/contractor/firms.
6. Reimbursement of Toll Tax paid by the individual/contractor/firms shall be made on production of receipt of payment of Toll Tax.


Other Conditions shall be as under:-

1. The Vehicle shall not be more than 5 years old. Only vehicle having Taxi permit with valid documents like Taxi permit, Insurance, Registration Certificate, Pollution Under Control Certificate etc. shall be considered.
2. The Vehicle is to be hired from 01.04.2017 to 31.03.2018 (12 Months), bill is to be submitted monthly in triplicate and payment shall be arranged on monthly basis. The rates/prices are firm inclusive of all taxes, duties, R&M, contribution of CPF/EPF/ESI & other liabilities except Service Tax Charges if applicable.
