4. Bill may be raised after completion of work.
5. Payment will be released by the Accounts Officer (T&C) RVPN, Chittorgarh in firm's bank account against delivery through RTGS/NEFT on receipt of invoice / bill.
6. The rates quoted should be inclusive of all taxes.
