Consent is hereby invited from competent and experienced firms / vehicle owners for deploying vehicle for site inspection of construction of Lines/GSS work falling under this division as per direction of higher authority having at least 1800 CC capacity with driver, diesel and repair & maintenance (THAR JEEP) on the rates, terms and condition approved by Finance Department GOR Circular dated 15.07.2015 as per details given below:-

The Rate as per circular is as follows:-

- For first 1500 Kms or less, Rs. 20000/- per month (service tax extra if applicable).
- For additional running of vehicle (more than 1500 Kms) the rate payable @ Rs. 7.25 per Km.
- Hired vehicles shall be used anywhere as per jurisdiction of the office. In case of night halt other than that of head quarter a sum of Rs. 200 per night shall be paid for the driver.
- The maximum ceiling of Rs. 23625/- per month (service tax extra if applicable) for 2200Kms for offices having jurisdiction of more than one district.
- All taxes except toll tax shall be borne by the individual/contractor/firm.
- Reimbursement of toll tax paid by the individual/ contractor/ firm shall be made on production of receipt of payment of toll tax.


Other Conditions shall be as under

- Vehicle shall not be of more than 6 year old. Only vehicles with taxi permit having valid documents like taxi permit insurance, fitness, registration, pollution certificate etc shall be considered
- The vehicle is to be hired from 01.04.2017 to 31.03.2018. Bill is to be submitted monthly and payment shall be arranged on monthly basis. The rates/Prices are firm inclusive of all taxes, duties, R&M & other liabilities except service taxes charge if applicable & toll tax.
