Terms & Condition :-

1. Tender shall be submitted online only through <http://eproc.rajasthan.gov.in>. The tender documents can be downloaded from this web site. The tender documents can be seen in respective division offices in office hours.
2. No physical /offline tender bid shall be accepted.
3. The Contractor must have sufficient experience of execution of similar type of works in govt. department/ public enterprises. He shall also upload his performance report, list of works executed during last year & work in hand and list of T & P etc.
4. The tender cost & Earnest money shall be in the form of Demand Draft or Banker cheque of Scheduled Bank drawn in favour of Accounts Officer (T&C), RRVNPL Kota payable at Kota for S.N.1 to 3, Accounts Officer (T&C), RRVNPL SawaiMadhopur for S.N. 4 to 6, Accounts Officer (T&C), RRVNPL Hindaun for S.N.. 7 & Accounts Officer (T&C), RRVNPL Bharatpur for S.N.. 8 shall be submitted offline / manually in office of the respective Executive Engineer (Civil), up to scheduled date & time. The bidders enlisted with the Chief Engineer (Civil) RVPN Jaipur & the Additional Chief Engineer (Civil) RVPN Jaipur in AA Class or A Class or B class, in respect circle office division office be deposited @ ½% Earnest money otherwise Earnest Money will be deposited @ 2% of estimated cost of work, for other department registered bidders in A or AA class shall be deposited @ 2% earnest money of the estimated cost. The Scan copy of DD/BC for earnest money , tender cost & processing fee shall also be uploaded.
5. The Processing fees shall be deposited in form of demand draft/Banker cheque of Scheduled Bank drawn in favour of Managing Director, RISL payable at Jaipur and shall be offline/ manually submitted in office of the respective Executive Engineer (Civil), up to scheduled date & time.
6. On award of contract, the work should have started within 15 days, otherwise work will be treated as withdrawn.
7. The undersigned reserves right to cancel the BID without assigning any reasons to the bidder or anyone else.
8. The water & Electricity shall be arranged by the bidder at his own source.
9. The Banas river sand only shall be arranged by the bidder at his own source
10. The bid price shall be inclusive of all taxes except GST, which will be payable at applicable rate by RVPNL.
11. The rates quoted will valid for 120 days from the date of opening of tender/bid.
12. The bidder shall have to submit a certificate that he has an establishment covered under the Provision of EPF Act, 1952 and having a separate registration with P.F. commissioner. In absence of the same, the contractor shall be liable to deposit employee's as well as employer's contribution (in respect of employees engaged by him for the said work) with RRVNPL along with details of such employees and deduction as per RVPN CPF rules shall be made from his bills/Security deposit.
13. Conditional tender & casual letters sent by the contractors will not be accepted.
14. Any representation after opening of tender shall be ignored. These parties may be debarred from tendering in future for a specific period. Their earnest money in such cases will stand forfeited.
15. The bidders should inspect the site of work prior to filling the tenders. These works shall be carried out in sub-station yard. The contractor should take all precautions & safety measures at his level to avoid any accident/ mis-happening & damages to Nigam's properties. In case of any accident / mis-happening & damages, the complete liability shall be rest with respective contractor.
16. The test moulds for respective work shall be transported by contractor to Quality Control Lab, Kota for testing at his own cost at time to time.
17. The qualified Engineer/Supervisor are to be depute by contractor at work site.

18. Temporary approach for construction, hutments for working Labour etc. are to be constructed by the contractor at his own cost & no payment shall be admissible for this.
19. Looking to urgency of work & matching the commissioning schedule of GSS, the contractor may be asked to complete the any part of work on priority and contractor will complete the said part as per requirement of department without any compensation.
20. Bidders are requested to read the instruction in the tender documents/bid before submitting the tender/bid online.
21. The above terms & condition of the bids may also be seen on RVPN website www.rpv.co.in along with bid invitation notice.
22. To participate in online tenders, bidders will have to procure digital signature certificate using which they can sign their electronic bids. 24. Tenderer should be registered with GST department. The copy of GST registration shall have to be uploaded in tendering.
