Terms & Conditions:-

1. Tender shall be submitted online only through <https://eproc.rajasthan.gov.in>. The tender documents can be downloaded from this web site. The tender documents can be seen in respective Division offices in office hours.
2. Tenderer should be registered under Goods & Service Tax Law.
3. The bid price shall be inclusive of all taxes except Goods & Service Tax (GST), which will be payable at applicable rate.
4. No physical/ offline Tender/ bid shall be accepted
5. The contractor must have sufficient experience of execution of similar type of works in Govt. department / Public Enterprises. He shall also upload his performance report, List of works executed during last five years & work in hand and list of T&P etc.
6. The Tender cost & Bid Security shall be deposited in the form of Demand draft or Banker cheque of Scheduled Bank drawn in favour of Accounts Officer (T&C), RRVNPL Kota payable at Kota for S.No.01 to 03 , Accounts Officer (T&C), RRVNPL Sawaimadhopur payable at Sawaimadhopur for S.No.04 to 09 and Accounts Officer (T&C), RRVNPL Hindaun payable at Hindaun for S.No.10 to 11 shall be submitted offline / manually in the office of the respective Executive Engineer (Civil) up to scheduled date & time. Bid Security will be deposited @ 2% of estimated cost of work. For departmental registered contractor Bid Security shall be deposited as per rules. The scan copy of DD/BC for Bid Security, Tender cost & processing fee shall also be uploaded. GST on tender cost shall be charged extra.
7. The processing fee Rs. 500/- or 1000/- as the case may be for each works shall be deposited in form of Demand draft/ Banker cheque of Scheduled Bank drawn in favour of Managing Director, RISL payable at Jaipur and shall be Offline/ manually submitted in the office of the respective Executive Engineer (Civil) up to scheduled date & time.
8. On award of contract, the work should have started within 15 days, otherwise work will be treated as withdrawn.
9. The undersigned reserves right to cancel the BID without assigning any reasons to the bidder or anyone else.
10. The water & electricity shall be arranged by the bidder at his own source.
11. Approved fine aggregate as per I.S. code / M Sand shall be used for civil works.
12. The rates quoted will valid for 90 days from the date of opening of tender/ bid.
13. The bidder shall have to submit a certificate that he has an establishment covered under the Provision of EPF Act, 1952 and having a separate registration with P.F commissioner. In absence of the same, the contractor shall be liable to deposit employee's as well as employer's contribution (in respect of employees engaged by him for the said work) with RRVNPL along with details of such employees and deduction as per RVPN CPF rules shall be made from his bills/ Security deposit.
14. Conditional tender & casual letters sent by the contractors will not be accepted.
15. Any representation after opening of tender shall be ignored. These parties may be debarred from tendering in future for a specific period. Their Bid Security in such cases will stand forfeited.
16. The bidders should inspect the site of work prior to filling the tenders. These works shall be carried out in Sub Station yard. The contractor should take all precautions & safety measures at his level to avoid any accident/ mis-happening & damages to Nigam's properties. In case of any accident/ mis-happening & damages, the complete liability shall be rest with respective contractor.

17. The test moulds, ferrow cement cover, CC Road core cutter, pavement blocks etc for respective works shall be transported by contractor to Quality Control Lab, Kota / Jaipur for testing at his own cost at time to time.
18. The qualified Engineer/ Supervisor are to be deputed by contractor at work site.
19. Temporary approach for construction, hutments for working labour etc. are to be constructed by the contractor at his own cost & no payment shall be admissible for this.
20. The provisions of Rajasthan Public Procurement Transparency Act-2012 & Rajasthan Public Procurement Transparency Rules-2013 shall be applicable.
21. To participate in online tenders, bidders will have to procure digital signature certificate using which they can sign their electronic bids. Bidders can procure the same from any CCA approved certifying agency or they may contact E-Procurement Cell, Department of IT & C, Govt. of Rajasthan, Yojna Bhawan, Tilak Marg, Scheme, Jaipur Contact No. 0141-4022688 for further assistance.
22. Bidders are requested to read the instruction in the tender documents/ bid before submitting the tender / bid on line.
23. Training for the bidders on the usage of e-Tendering system is also being arranged by RISL on regular basis. Bidders interested for training may contact e-Procurement Cell RISL for booking the training slot.
24. Looking to urgency of work & matching the commissioning schedule of GSS, the contractor may asked to complete the any part of work on priority and contractor will complete the said part as per requirement of department without any compensation.
25. A bid is to be considered imbalance if the bid price offered by the bidder is more than 10% lower than the cost work out on the basis of justified rates, then the additional performance security shall be deposited by the bidder as per CE (Civil), RVPN, Jaipur order No.D.01 dated 01.04.2019.

CIRCULAR

Sub: Additional Performance security on un-balanced bids.

A Bid is to be considered un-balanced if the Bid price offered by the bidder is more than 10% lower than the cost worked out on the basis of justified rates. For the purpose of determination of additional performance security, implemented PWD BSR rates shall be considered as the justified rates and items rates as per approved rates by competent authorities. It should be then uploaded on site before Bid receipt date in accordance with RTPP rules.


If "A" is the scheduled/justified rate of the work, then additional performance security shall be equal to:-

$$(0.9 \times A - \text{Bid Amount}) \times 0.4$$

[(Point nine multiplied by A minus Bid amount) multiplied by point four]


The additional performance security will be refundable after satisfactory completion of the work. This order will be applicable from the date of issue of order for all type of civil work undertaken by the RVPN civil wing. (Not for ongoing orders).
