Terms & Condition :-

1. Tender shall be submitted online only through <http://eproc.rajasthan.gov.in>. The tender documents can be downloaded from this web site. The tender documents can be seen in respective division offices in office hours.
2. No physical /offline tender bid shall be accepted.
3. The Contractor must have sufficient experience of execution of similar type of works in govt. department/ public enterprises. He shall also upload his performance report, list of works executed during last year & work in hand and list of T & P etc.
4. The tender cost & Earnest money shall be in the form of Demand Draft or Banker cheque of Scheduled Bank drawn in favour of Accounts Officer (T&C), RRVPNL Kota payable at Kota for S.N.1 to 3, Accounts Officer (T&C), RRVPNL Sawaimadhopur payable at Sawaimadhopur for S.N.4 to 5 and Accounts Officer (T&C), RRVPNL Hindaun payable at Hindaun for S.N. 6 to 7, shall be submitted offline / manually in office of the respective Executive Engineer (Civil), up to scheduled date & time. The bidders enlisted with the Chief Engineer (Civil) RVPN Jaipur & the Additional Chief Engineer (Civil) RVPN Jaipur in AA Class or A Class or B class, in respect circle office division office be deposited @ ½% Earnest money otherwise Earnest Money will be deposited @ 2% of estimated cost of work, for other department registered bidders in A or AA class shall be deposited @ 2% earnest money of the estimated cost. The Scan copy of DD/BC for earnest money , tender cost & processing fee shall also be uploaded.
5. The Processing fees shall be deposited in form of demand draft/Banker cheque of Scheduled Bank drawn in favour of Managing Director, RISL payable at Jaipur and shall be offline/ manually submitted in office of the respective Executive Engineer (Civil), up to scheduled date & time.
6. On award of contract, the work should have started within 15 days, otherwise work will be treated as withdrawn.
7. The undersigned reserves right to cancel the BID without assigning any reasons to the bidder or anyone else.
8. The water & Electricity shall be arranged by the bidder at his own source.
9. The Banas river sand or approved fine aggregate as per I.S. code shall be used for civil works.
10. The bid price shall be inclusive of all taxes except GST, which will be payable at applicable rate by RVPNL.
11. The rates quoted will valid for 90 days from the date of opening of tender/bid.
12. The bidder shall have to submit a certificate that he has an establishment covered under the Provision of EPF Act, 1952 and having a separate registration with P.F. commissioner. In absence of the same, the contractor shall be liable to deposit employee's as well as employer's contribution (in respect of employees engaged by him for the said work) with RRVPNL along with details of such employees and deduction as per RVPN CPF rules shall be made from his bills/Security deposit.
13. Conditional tender & casual letters sent by the contractors will not be accepted.
14. Any representation after opening of tender shall be ignored. These parties may be debarred from tendering in future for a specific period. Their earnest money in such cases will stand forfeited.
15. The bidders should inspect the site of work prior to filling the tenders. These works shall be carried out in sub-station yard. The contractor should take all precautions & safety measures at his level to avoid any accident/ mis-happening & damages to Nigam's properties. In case of any accident / mis-happening & damages, the complete liability shall be rest with respective contractor.

16. The test moulds, ferrow cement cover, CC Road core cutter, pavement blocks for respective works shall be transported by contractor to Quality Control Lab, Kota for testing at his own cost at time to time and payment shall be made accordingly.
17. The qualified Engineer/Supervisor are to be depute by contractor at work site.
18. Temporary approach for construction, hutments for working Labour etc. are to be constructed by the contractor at his own cost & no payment shall be admissible for this.
19. Looking to urgency of work & matching the commissioning schedule of GSS, the contractor may asked to complete the any part of work on priority and contractor will complete the said part as per requirement of department without any compensation.
20. Bidders are requested to read the instruction in the tender documents/bid before submitting the tender/bid online.
21. The above terms & condition of the bids may also be seen on RVPN website www.rvpn.co.in along with bid invitation notice.
22. To participate in online tenders, bidders will have to procure digital signature certificate using which they can sign their electronic bids. Bidders can procure the same from any CCA approved certifying agency or they may contact e-Procurement Cell, Department of IT & C, Govt. of Rajasthan, Yojna Bhawan, Tilak Marg, C-Scheme, Jaipur Contact No. 0141-4022688 for further assistance.
23. Training for the bidders on the usage of e-Tendering system is also being arranged by RISL on regular basis. Bidders interested for training may contact e-Procurement Cell RISL for booking the training slot.
24. Tenderer should be registered with GST department. The copy of GST registration shall have to be uploaded in tendering.
25. The provisions of Rajasthan Public Procurement Transparency Act -2012 & Rajasthan Public Procurement Transparency Rules-2013 shall be applicable.
26. A bid is to be considered imbalance. If the bid price offered by the bidder is more than 10% lower than cost the cost work out on the basis of justified rates. Than the additional performance security shall be deposited by the bidder as per CE (Civil) RVPN jaipur order No D.01 dated 01.04.2019

CIRCULAR

Sub: Additional Performance security on un-balanced bids.

A Bid is to be considered un-balanced if the Bid price offered by the bidder is more than 10% lower than the cost worked out on the basis of justified rates. For the purpose of determination of additional performance security, implemented PWD BSR rates shall be considered as the justified rates and items rates as per approved rates by competent authority. It should be then uploaded on site before Bid receipt date in accordance with RTPP rules.


If "A" is the scheduled/justified rate of the work, then additional performance security shall be equal to:-

$$(0.9 \times A - \text{Bid Amount}) \times 0.4$$

[(Point nine multiplied by A minus Bid amount) multiplied by point four]

The additional performance security will be refundable after satisfactory completion of the work. This order will be applicable from the date of issue of order for all type of civil work undertaken by the RVPN civil wing. (Not for ongoing orders).
