**Terms & Conditions:-**

- Bids shall be submitted online only through <http://eproc.rajasthan.gov.in>. The bid documents can be downloaded from this web site. The bid documents can be seen in respective Division offices in office hours.
- Bidders should be registered under Goods & Service Tax Law. The copy of GST registration shall have to be uploaded in bidding.
- The bid price shall be inclusive of all taxes except Goods & Service Tax (GST), which will be payable at applicable rate by RVPN and the validity of rates will be 90 days.
- The Bidders are requested to submit their bid prior to last date of submission to avoid Non-submission of their bids up to prescribed date & time due to non-availability/hanging of website at last moments or any reason whatsoever. The last date of submission of bids will not be extended on such accounts.
- Furnishing Bid Security/ Valid bid securing declaration & proof for deposit / acknowledgement of Bid Security, e-bidding processing fees & cost of bid specification before techno-commercial bid opening is essential uploaded in envelop-I otherwise the techno-commercial bid in electronic form (cover II & III) will not be opened.
  - The bidder will have to deposit prescribed Bid Security by Demand draft or Banker cheque of Scheduled bank drawn in favour of Accounts Officer (T&C), RVPNL, Ajmer payable at Ajmer for the works mentioned at S.No. 1 and shall be submitted offline / manually in the office of the Executive Engineer (Civil),RVPN, Ajmer up to scheduled date & time and scan copy of DD/ banker cheque shall be uploaded along with their online bid. The firms registered with Small Scale Industries of Rajasthan as MSME are also required to furnish the bid security as 0.5% of the estimated value of bid and in case of sick industries, other than Small Scale Industries, whose cases are pending with Board of Industrial and Financial Reconstruction; it shall be 1% of the estimated cost.

- (ii) The bidder will have to deposit **prescribed processing fee as mentioned against each work in form of Demand draft/ Banker cheque of Scheduled Bank drawn in favour of Managing Director, RISL payable at Jaipur and shall be Offline/ manually submitted in the office of the Executive Engineer (Civil), RVPN, Ajmer** up to scheduled date & time and scanned copy of DD shall be uploaded along with their online bid.
6. Cutting / Over writing if any in the figures of the bidding documents is required to be clarified/ indicated in words duly signed failing which bid may be ignored.
  7. RRVPNL reserves the right to accept minor deviation(s) in qualifying requirement and techno-commercial conditions on its merits. Deviation of any kind shall "not" be quoted in the price bid, if found quoted, the same shall be ignored.
  8. The purchaser will respond in writing to any request for clarification on bid documents if any, such request shall be received in the office of the XEN (Civil), RVPN, Ajmer prior to 7 days of bid submission. Later request shall not be entertained.
  9. The Bidder should provide complete information at the time of submission of bid. However, if the bidders are asked to furnish some clarification/ confirmation/ documents, the bidders are required to furnish the same within specified time failing which, the case shall be finalized/decided on the basis of available information. The responsibility of their bid being ignored on account of delay in furnishing of desired information / documents shall be of the bidder.
  10. All bid documents shall essentially be signed digitally and submitted on <http://eproc.rajasthan.gov.in> in time as per checklist provided with the bid document. The check list along with relevant page nos. shall be submitted with the bid
  11. If the bidder is a Micro, Small or Medium Enterprise as per the Micro, Small and Medium enterprise development act, 2006 (MSMED act-2006) and registered with the District Industries Centre under the above act for the items. Services covered under this bid, then the bidder has to indicate the Entrepreneurs Memorandum No. (Twelve Digits) and upload notary attested copy of the acknowledgment of EM-11 issued by the authorities under the MSME act-2006 and an affidavit in prescribed format at Appendix-V of specification with its bid documents.
  12. The Firm shall arrange the inspection of ready sample of all type of furniture. The manufacturing of all type of furniture shall be commenced after the approval of sample of furniture and thereafter the RVPN committee also carried out the inspection of ready furniture as per Guaranteed Technical parameters and drawing of furniture. The cost of inspection shall be borne by the RVPN.
  13. Payment shall be made to the supplier/contractor through RTGS/NEFT for quick and safe transfer of funds across the country. The charges for transfer through RTG/NEFT shall be on the part of the supplier/contractor.
  14. To participate in online tenders, bidders will have to procure digital signature certificate using which they can sign their electronic bids.   16. All the required information shall be furnished strictly in prescribed Schedules/Formats only. Any information included other than the prescribed schedules/formats shall not be entertained. The bid shall be evaluated on the basis of information furnished in the prescribed Schedule/Formats.
