Terms & Conditions:-

- Tender shall be submitted online only through <http://eproc.rajasthan.gov.in>. The tender documents can be downloaded from this web site. The tender documents can be seen in respective Division offices in office hours.
- Tenderer should be registered under Goods & Service Tax Law.
- The bid price shall be inclusive of all taxes except Goods & Service Tax (GST), which will be payable at applicable rate by RVPNL.
- A bid is to be considered un-balanced if the bid price offered by the bidder is more than 10% lower than the cost worked out on the basis of justified rates. For such un-balanced bid the bidder need to deposit additional performance security which will be refundable after satisfactory completion of the work.
- No physical/ offline Tender/ bid shall be accepted.
- The contractor, except Registered Contractor RVPN must have sufficient experience of execution of similar type of works in Govt. department / Public Enterprises. They shall also upload his performance report, List of works executed during last three year & work in hand and list of T&P etc.
- The Tender cost & Earnest Money shall be deposited in the form of Demand draft or Banker cheque of Scheduled bank drawn in favour of following Accounts Officer (T&C) as narrated below


The above narrated DD and Banker Cheque required for Tender Cost/Bid Security/Processing fee shall be submitted offline / manually in the office of the respective Executive Engineer (Civil) up to scheduled date & time. Earnest Money will be deposited @ 2% of estimated cost of work.

The aforesaid Demand draft or Banker cheque shall be issued in the name of applicant's only; Demand draft or Banker cheque issued by any other name/firm shall not be accepted.

For RVPNL departmental registered contractor earnest money shall be deposited as per rules. The scan copy of DD/BC for Earnest Money, Tender cost & processing fee shall also be uploaded. GST @18% on Tender Cost shall be charged extra.


- The processing fee as mentioned against each work shall be deposited in form of Demand draft/ Banker cheque of Scheduled Bank drawn in favour of Managing Director, RISL payable at Jaipur and shall be Offline/ manually submitted in the office of the respective Executive Engineer (Civil) up to scheduled date & time.
- On award of contract, the work should have started within 15 days, otherwise work will be treated as withdrawn.
- The undersigned reserves the right to cancel the BID without assigning any reasons to the bidder or anyone else.
- The cement, water & electricity shall be arranged by the bidder at his own source.

12. Manufactured sand (M-Sand)/ River Sand as per relevant IS code provision shall be used for construction work mentioned above.
13. The rates quoted will valid for 90 days from the date of opening of tender/ bid.
14. The bidder shall have to submit a certificate that he has an establishment covered under the Provision of EPF Act, 1952 and having a separate registration with P.F commissioner. In absence of the same, the contractor shall be liable to deposit employee's as well as employer's contribution (in respect of employees engaged by him for the said work) with RRVPNL along with details of such employees and deduction as per RVPN CPF rules shall be made from his bills/ Security deposit.
15. Conditional tender & casual letters sent by the contractors will not be accepted.
16. Any representation after opening of tender shall be ignored. These parties may be debarred from tendering in future for a specific period. Their earnest money in such cases will stand forfeited.
17. **The bidders should thoroughly inspect the site of each item of work prior to filling the tenders. These works shall be carried out in Sub Station yard. The contractor should take all precautions & safety measures at his level to avoid any accident/ mis-happening & damages to Nigam's properties. In case of any accident/ mis-happening & damages, the complete liability shall be rest with respective contractor.**
18. The work shall be executed as per approved design, drawings and specification approved by Nigam.
19. The test cube moulds/ samples for respective work shall be transported by contractor to RVPNL Quality Control Lab, Ajmer for testing ,at his own cost at time to time.
20. The qualified Engineer/ Supervisor are to be depute by contractor at work site.
21. Temporary approach for construction, hutments for working labour etc. are to be constructed by the contractor at his own cost & no payment shall be admissible for this.
22. The provisions of Rajasthan Transparency Public Procurement Act-2012 & Rajasthan Transparency Public Procurement Rules-2013 and its amendments shall be applicable.
23. To participate in online tenders, bidders will have to procure digital signature certificate using which they can sign their electronic bids. Bidders can procure the same from any CCA approved certifying agency or they may contact e_Procurement Cell, Department of IT & C, Govt. of Rajasthan, Yojna Bhawan, Tilak Marg, C-Scheme, Jaipur Contact No. 0141-4022688 for further assistance.
