

1. Bids shall be submitted online only through <http://eproc.rajasthan.gov.in>. The bid documents can be downloaded from this web site. The bid documents can be seen in respective Division offices in office hours.


2. Bidders should be registered in GST act. The copy of GST registration shall have to be uploaded in bidding .
3. The bid price shall be inclusive of all taxes except GST, which will be payable at applicable rate.
4. The bidders are requested to submit their bids prior to last date of submission to avoid Non-submission of their bids up to prescribed date & time due to non-availability/ hanging of website at last moments or any reason whatsoever. The last date of submission of bids will not be extended on such accounts.
5. Furnishing of Bid Security/ Valid bid securing declaration & proof for deposit/ acknowledgement of Bid Security. e-bidding processing fees & cost of bid Specification before techno-commercial bid opening is essential otherwise the techno-commercial bid in electronic form (cover II and III) will not be opened.
  - (i) The bidder will have to deposit prescribed Bid Security by DD/Banker's Cheque payable in favour of Accounts Officer (T&C-Jaipur City), RVPN Ltd., Jaipur payable at Jaipur for S.No. 1 & 2 up to stipulated date & time, offline in the office of the respective Executive Engineer(Civil-Jaipur City), RVPN, Jaipur and scan copy of DD shall be uploaded along with their online bid. The firms registered with Small Scale Industries of Rajasthan as MSME are also required to furnish the bid security as 0.5% of the estimated value of bid and in case of sick industries, other than Small Scale Industries, whose cases are pending with Board of Industrial and Financial Reconstruction; it shall be 1% of the estimated value of bid.
  - (ii) The bidder will have to deposit prescribed Processing Fee by DD/Banker's Cheque in favour of Managing Director, RISL, payable at Jaipur up to stipulated date & time offline in the office of Executive Engineer(Civil-Jaipur City) , RVPN, Jaipur, Chambal GSS Premises, Hawa Sarak, Jaipur and scan copy of DD shall be uploaded along with their online bid.
6. Cutting / overwriting if any in the figures of the bidding documents is required to be clarified / indicated in words duly signed failing which bid may be ignored.
7. RRVPNL reserves the right to accept minor deviation(s) in qualifying requirement and techno - commercial conditions on its merits. Deviation of any kind shall "not" be quoted in the price bid, if found quoted, the same shall be ignored.
8. The purchaser will respond in writing to any request for clarification on bid documents if any, such request shall be received in office of the XEN (Civil – Jaipur City), RVPN, Jaipur prior to 15 days of bid submission . Later request shall not be entertained.
9. The bidders should provide complete information at the time of submission of bid. However, if the bidders are asked to furnish some clarification/ confirmation/documents, the bidders are required to furnish the same within specified time failing which, the case shall be finalized /decided on the basis of available information. The responsibility of their bid being ignored on account of delay in furnishing of desired information/documents shall be of the bidder.
10. All bid documents shall essentially be signed digitally and submitted on <http://eproc.rajasthan.gov.in> in time as per checklist provided with the bid document. The checklist along with relevant page nos. shall also be submitted with the bid.
11. If the bidder, is a Micro, Small or Medium enterprise as per the Micro, Small and Medium enterprise development act, 2006 (MSMED Act-2006) and registered with the District Industries Centre under the above act for the items/services covered under this bid, then the bidder has to indicate the Entrepreneurs Memorandum No. (Twelve digit) and upload notary attested copy of the acknowledgement of EM-II issued by the authorities under the MSME act-2006 and an affidavit in prescribed format at Appendix-V of specification with its bid documents.
12. Payment shall be made to the supplier/contractor through RTGS/NEFT for quick and safe transfer of funds across the country. The charges for transfer through RTGS/NEFT shall be on the part of the supplier/ contractor. The supplier/contractor shall furnish particulars to the payment making authority of RVPN in prescribed format enclosed at Schedule-XI.
13. To participate in online tenders, bidders will have to procure digital signature certificate using which they can sign their electronic bids. Bidders can procure the same from any CCA approved certifying agency or they may contact e\_Procurement Cell, Department of IT & C, Govt. of Rajasthan, Yojna Bhawan, Tilak Marg, Scheme, Jaipur Contact No. 0141-4022688 for further assistance.

14. Bidder shall submit their offer online in electronic formats both for technical and financial proposals. However, cost of Bid specification, Bid Security & processing fee by DD/Banker's Cheque should be submitted physically upto stipulated date and time in the office of XEN (Civil-Jaipur City), Jaipur, Chambal GSS Premises Hawa Sadak , Jaipur . The bidder shall upload scanned copies of DD of above fee documents along with their online bid.
15. All the required information shall be furnished strictly in prescribed Schedules/Formats only. Any information indicated other than the prescribed schedules/formats shall not be entertained. The bid shall be evaluated on the basis of information furnished in the prescribed Schedules/Formats.
16. Physical submission of bids is not allowed.
17. No conditional bids shall be accepted and will be rejected summarily forthwith.
