2. Tenderer should be registered under Goods & Service Tax Law.
3. The bid price shall be inclusive of all taxes except Goods & Service Tax (GST), which will be payable at applicable rate.
4. No physical/ offline Tender/ bid shall be accepted.
5. The contractor must have sufficient experience of execution of similar type of as laid down in bid document. As per qualifying criteria, he shall also upload his performance report, List of works executed & work in hand as required in tender specification.
6. The Tender cost & Bid Security shall be deposited in the form of Demand draft or Banker cheque of Scheduled Bank drawn in favour of Accounts Officer (T&C-Jaipur City), RRVN payable at Jaipur and shall be submitted offline / manually in the office of the respective Executive Engineer (Civil) up to scheduled date & time.
