RVPNL invites competitive BIDS for the following civil works from experienced, reputed contractors registered in appropriate class with RRVPNL (Civil Jaipur Zone) & A or AA class in Central/ state Government Department and their undertakings and/or scrap dealers having minimum turnover of 20 lakh total in last three (3) financial years including current financial year & registered for GST. The Tender/bid shall only be submitted through online e-tendering system of <https://eproc.rajasthan.gov.in>. The interested bidders shall have to be enrolled/ registered with portal of <https://eproc.rajasthan.gov.in> for participating in the bidding process.

Terms & Conditions:

- The successful bidder shall deposit Rs. 15 Lakh by DD/ Banker's Cheque drawn in favor of Accounts Officer (T&C- Jaipur City) payable at Jaipur prior to lifting of the scrap material from Vidyut Bhawan, which shall be adjusted towards the cost of the scrap material. This amount of 15 lakhs shall be adjusted in the final bill of the firm.
- Tender shall be submitted online only through <https://eproc.rajasthan.gov.in>. The tender documents can be downloaded from this web site. The tender documents can be seen in respective Division offices in office hours.
- Tenderer should be registered under Goods & Service Tax Law.
- The bid price shall be inclusive of all taxes except Goods & Service Tax (GST), which will be payable at applicable rate.
- No physical/ offline Tender/ bid shall be accepted.
- The contractor must have sufficient experience of execution of similar type of works in Govt. department / Public Enterprises. He shall also upload his performance report, List of works executed during last five years & work in hand and list of T&P etc.
- The Tender cost & Bid Security shall be deposited in the form of Demand draft or Banker cheque of Scheduled Bank drawn in favour of Accounts Officer (T&C-Jaipur City), RRVPNL payable at Jaipur for the work mentioned at Sr. 1 shall be submitted offline / manually in the office of the respective Executive Engineer (Civil), Alwar up to scheduled date & time. Bid Security will be deposited @ 2% of estimated cost of work. For departmental registered contractor Bid Security shall be deposited as per rules. The scan copy of DD/BC for Bid Security, Tender cost & processing fee shall also be uploaded. GST on tender cost shall be charged extra.
- The processing fee Rs. 500/- or 1000/- as the case may be for each works shall be deposited in form of Demand draft/ Banker cheque of Scheduled Bank drawn in favour of Managing Director, RIBL payable at Jaipur and shall be Offline/ manually submitted in the office of the respective Executive Engineer (Civil) up to scheduled date & time.
- On award of contract, the work should have started within 15 days, otherwise work will be treated as withdrawn.
- The undersigned reserves right to cancel the BID without assigning any reasons to the bidder or anyone else.
- The water & electricity shall be arranged by the bidder at his own source.
- The approved wash crusher sand / M-sand shall only be used for above construction works..
- The rates quoted will valid for 90 days from the date of opening of tender/ bid.
- The bidder shall have to submit a certificate that he has an establishment covered under the Provision of EPF Act, 1952 and having a separate registration with P.F commissioner. In absence of the same, the contractor shall be liable to deposit employee's as well as employer's contribution (in respect of employees engaged by him for the said work) with RRVPNL along with details of such employees and deduction as per RVPN CPF rules shall be made from his bills/ Security deposit.
- Conditional tender & casual letters sent by the contractors will not be accepted.
- Any representation after opening of tender shall be ignored. These parties may be debarred from tendering in future for a specific period. Their Bid Security in such cases will stand forfeited.

17. The bidders should inspect the site of work prior to filling the tenders. These works shall be carried out in Sub Station yard. The contractor should take all precautions & safety measures at his level to avoid any accident/ mis-happening & damages to Nigam's properties. In case of any accident/ mis-happening & damages, the complete liability shall be rest with respective contractor.
18. The test moulds for respective work shall be transported by contractor to Quality Control Lab, Jaipur for testing, at his own cost at time to time.
19. The qualified Engineer/ Supervisor are to be deputed by contractor at work site.
20. Temporary approach for construction, hutments for working labour etc. are to be constructed by the contractor at his own cost & no payment shall be admissible for this.
21. The provisions of Rajasthan Public Procurement Transparency Act-2012 & Rajasthan Public Procurement Transparency Rules-2013 shall be applicable.
22. To participate in online tenders, bidders will have to procure digital signature certificate using which they can sign their electronic bids. Bidders can procure the same from any CCA approved certifying agency or they may contact e-Procurement Cell, Department of IT & C, Govt. of Rajasthan, Yojna Bhawan, Tilak Marg, Scheme, Jaipur Contact No. 0141-4022688 for further assistance.
