Circular No. F.9(1)FD.1(1) Budget/2015 Jaipur dated 15.07.2015 as per details given below:

The rates as per this circular are as follows:

1. For first 1500 KMs or less, 20,000/- per month (service tax extra if applicable).
2. For additional running of vehicle (more than 1500 KMs) the rate payable @ Rs. 7.25 per Km.
3. Hired vehicles shall be used anywhere as per jurisdiction of the office where deployed. In case of night halt other than that of head quarter a sum of Rs. 200 per night shall be paid for the driver.
4. The maximum ceiling of Rs. 25075/- per month (service tax extra if applicable) for 2200 KMs for offices having jurisdiction of more than one district.
5. All taxes except toll tax shall be borne by the individual/ contractor/firm.
Reimbursement of toll tax paid by the individual/ contractor/firm shall be made on production of receipt of payment of toll tax.

Other conditions shall be as under :

1. Vehicle shall not be more than 6 years old. Only vehicles with taxi permit having valid documents shall be considered
2. The vehicle is to be hired from 01.07.2016 to 31.03.2017 (9 months). Bill is to be submitted monthly and payment shall be arranged on monthly basis.
3.
