Circular No. F.2(4)FD/SPFC/2017, Jaipur dated 31/03/2021 as per details given below:

The rates as per this circular are as follows:

1. For first 1500 KMs or less, 26,400/- per month (GST extra if applicable).
2. For additional running of vehicle (more than 1500 KMs) the rate payable @ Rs. 10.00/- per Km.
3. Hired vehicles shall be used anywhere, as per jurisdiction of the office/circle where deployed or anywhere in Rajasthan with permission of competent authority. In case of night halt other than that of head quarter a sum of Rs. 300 per night shall be paid for the driver.
4. The maximum ceiling of Rs. 31,350/- per month (GST extra if applicable) for 2000 KMs for offices having a(One) district as their jurisdiction and Rs. 33,330/- per month (GST extra if applicable) for 2200 KMs for offices having jurisdiction of more than one district but less than the whole state.
5. All taxes except toll tax shall be borne by the individual/ contractor/firm. Reimbursement of toll tax paid by the individual/ contractor/firm shall be made on production of receipt of payment of toll tax.

Other conditions shall be as under :

1. Vehicle shall not be more than 6 years old.(In case the vehicle is more than 6 years old , and the condition of vehicle is satisfactory then the Nigam can give the relaxation of not more than 2 years, i.e. vehicle should not be more than 8 years old). Only vehicles with taxi permit having valid documents shall be considered
2. The vehicle is to be hired from 01/04/2022 to 31/03/2023 (12 months). Bill is to submitted monthly and payment shall be arranged on monthly basis.
