Consent is invited from competent and experienced firms/ vehicle owners for deploying inspection vehicle (Jeep/Bolero/Maruti Swift/Tata Indica/Indigo etc.) w.e.f. 01.04.2020 to 31.03.2021 on the rates, terms & conditions approved by the Finance Department Circular vide No. F.2(4)FD./SPFC/2017 dated 19 July 2018 and adopted by nigam's order vide No.RVPN/DS/GAD/F.Norms of Vehicle/18-19/D.512 Jaipur Dt. 25.09.2018 & rate revision vide Circular No. F.2(4)FD./SPFC/2017 Jaipur dated 28.02.2019 as per details given below:

The Rates as per this circular are as follows:-

1. For first 1500 KMs or less Rs. 24,000/- per month (GST extra if applicable) will be paid.
2. For additional running of vehicle (more than 1500 KMs) the rate payable @ Rs. 9.00/- per KM.
3. The maximum ceiling of Rs.30300/- per month (GST extra if applicable) for **2200 KMs** for offices having jurisdiction of more than one district but less than the whole state.
4. Hired vehicle shall be used, anywhere in the jurisdictional area of the officer concerned. In case of night halt other than that of headquarter a sum of Rs. 300 per night shall be paid for the driver.
5. All taxes except Toll Tax & GST shall be borne by the individual/ contractor/ firm. Reimbursement of Toll Tax paid by the individual/ contractor / firm shall be made on production of receipt of payment of Toll Tax. GST will be applicable as per circular vide No./RVPN/CAO(P&C)/ AO(P&C-II)/D.1770 Dated 28.01.2020 of Chief Accounts Officer (P&C) RVPN Jaipur.
6. If any rate revision is issued by the Finance Department and subsequently adopted by RVPN the revised rates will be applicable.

Other terms and conditions shall be as under:-

1. Vehicle shall not be more than 6 years old. Only vehicles with taxi permit having valid documents shall be considered.
2. The vehicle is to be hired for a period from 01.04.2020 to 31.03.2021. Bill is to be submitted monthly to the concern office incharge who will verify it & send the same to the concern Accounts Officer (T&C), RVPN for Payment. The payment will be made through online banking or A/C Payee Cheque/DD and payment shall be arranged on monthly basis.
