#### **The rates as per this circular are as follows:**


1. For first 1500 KMs or less, 26,400/- per month (service tax extra if applicable).
2. For additional running of vehicle (more than 1500 KMs) the rate payable @ Rs. 10 per Km.
3. Hired vehicles shall be used anywhere as per jurisdiction of the office where deployed. In case of night halt other than that of head quarter a sum of Rs. 300 per night shall be paid for the driver.
4. The maximum ceiling of Rs. 31350/- per month (GST extra if applicable will be borne by RVPN) for 2000 KMs for offices having jurisdiction of one district. And Rs. 33,330/- per month (GST extra if applicable will be borne by RVPN) for 2200 KMs for offices having jurisdiction of more than one district.
5. All taxes except Toll Tax & GST shall be borne by the individual/ contractor/firm. Reimbursement of Toll Tax paid by the individual/ contractor/firm shall be made on

6. If any rate revision is issued by the finance department and subsequently adopted by RVPN the revised rates will be applicable.
7. The period of hiring of vehicle may be increased or decreased as per requirement.

1. Vehicles with taxi permit having valid documents shall be considered.
2. The vehicle is to be hired from as per above schedule. Bill is to be submitted monthly and payment shall be arranged on monthly basis.
