The salient points/ Terms & Condition are as under:

1. The sealed tenders are being invited by Superintending Engineer (Commn.), Rajasthan Rajya Vidyut Prasaran Nigam Limited Jodhpur having office at New Power House, Jodhpur (Rajasthan) and Tender specification are to be purchased from this office. Email ID se.comm.jodh@rvpn.co.in
 2. The procurement process shall be governed by RTPP act 2012 and RTPP Rules 2013.
 3. The procurement is being done through single stage bid.
 4. The Bid shall be submitted in closed/sealed envelope duly super scribed as **"Hiring of Vehicle for Bid No....."**
 5. The vehicle should not be more than six years old at the time of opening of tender. Only vehicles with taxi permit having valid documents shall be considered.
 6. The bid cost (non refundable) and bid security as given above shall be deposited in cash or through demand draft / crossed cheque/RTGS/NEFT respectively; Payable to the **Accounts Officer(T&C) RVPN Jodhpur.**
 7. The bids will be accepted up to 2.30 PM of dated 23.06.2020 and shall be opened at 3.00 pm on dated 23.06.2020 in the presence of available bidders.
 8. Photocopies of registration certificate, insurance, road tax, driving license, pollution under control and relevant documents are to be submitted with bid.
 9. The Vehicle is to be hired for the period 01.07.2020 to 31.03.2021 for offices mentioned at Sr. No 1 to 7 and for the period 01.08.2020 to 31.03.2021 for the office mentioned at Sr. No 8.
 10. Any Compensation payable for damage due to accident by vehicle or driver to any party/property shall be borne by the vehicle owner/insurer of vehicle. The vehicle must be fully insured (Comprehensive) by vehicle owner. The department will not be responsible in any case for the same.
 11. The safety and security of the vehicle shall not be responsibility of RVPN.
 12. Income tax and any other taxes if applicable will be levied/ charged as per government rules and GST will be applicable as per circular vide No./RVPN/CAO(P&C)/AO (P&C-II)/D. 1770 Dated 28.01.2020 of Chief Accounts Officer (P&C) RVPN Jaipur.
 13. Monthly Bill should be prepared and submitted in the concerned office in triplicate. The same will be verified by Controlling Officer and submitted to the concerned Accounts Officer. The AO (T&C) Concerned will arrange payment through RTGS.
 14. All Vehicle running expenses and repair and maintenance or vehicle will be in scope of vehicle owner.
 15. In case of any outage/ damage of vehicle than substitute of the same will be arranged by vehicle owner.
 16. RVPN has right to reject any bid without assigning any reason.
 17. Period of contract may be extended or reduced as per requirement of vehicle.
 18. RVPN has all right to terminate the contract with a notice period of seven days.
 19. If service of hired vehicle found unsatisfactory the contract would be terminated immediately without any notice period.
 20. All other duties taxes of vehicle is to be borne by vehicle owner, except toll tax. Toll tax paid by vehicle driver/owner will be reimbursed by RVPN on submission of receipt of toll tax/fast tag statement.
 21. Performance security on the basis of annual expenditure on hiring of vehicle as provided in Rajasthan Transparency in public procurement rules 2013 shall be deposited by successful bidder or deducted from monthly running bill which will be refunded after completion of contract.
