CONSENT FOR HIRING OF VEHICLE ON GOVT. OF RAJASTHAN RATES & TERMS

Consent is invited from competent and experienced firm/vehicle owners for deploying inspection vehicle (Car Swift Dzire or equivalent) on the rates, terms and conditions approved by Finance Department GOR. Circular No.F.2(4)FD/SPFC/2017 Jaipur Dated 19.07.2018 and its amendment on dated 28.02.2019 as per details given below-

The rates as per this circular are as follows:

1. For first 1500 Kms or less, 24,000/- per month (GST extra, if applicable).
2. For additional running of vehicle (more than 1500 Kms) the rate payable @ Rs. 9.00 per Km.
3. Hired vehicle shall be used anywhere in jurisdiction of RVPN. In case of night halt other than that of head quarter a sum Rs. 300/- per night shall be paid for the driver.
4. The maximum ceiling of Rs. 28,500/- per month (GST extra, if applicable) for 2000 Kms for offices having a district as their jurisdiction.
5. The maximum ceiling of Rs. 30,300/- per month (GST extra, if applicable) for 2200 Kms for offices having a district as their jurisdiction of more than one district but less than the whole state.
6. The maximum ceiling of Rs. 33,000/- per month (GST extra, if applicable) for 2500 Kms for official use in respect of those offices whose functional and operational jurisdiction is spreading over the entire state.
7. All taxes except toll tax shall be borne by the individual/contractor/firm. Reimbursement of toll tax paid by the individual/contractor/firm shall be made on production of receipt of payment of toll tax.

Other conditions shall be as under:

1. Vehicle shall not be more than 6 years old. Only vehicles with taxi permit having valid documents shall be considered.
2. The vehicle is to be hired from 01.04.2020 to 31.03.2021 (12 months). Bill is to submitted monthly and payment shall be arranged on monthly basis.
3. The consent is being invited by Superintending Engineer (Communication) Rajasthan Rajya Vidyut Prasaran Nigam Limited, having office at 220 KV GSSHeerapura, Jaipur or the Name of respective office/location where hired vehicle is required and consent is to be sent on aforementioned address.
