Consent is invited from competent and experienced firm/vehicle owners for deploying inspection vehicle (Car / Jeep/ Bolero) w.e.f 01.04.2022 to 31.03.2023 on the rates, terms and conditions approved by Finance Department GOR. Circular No.F.2 (4)FD /SPFC/2017 Jaipur Dated 19.07.2018 and further approved by Nigam's Order vide No. RVPN/DS/GAD/F. Norms of Vehicle/18-19/D.512 dated 25.09.2018 & rate revision vide circular No. F.2 (4)/FD/SPFC/2017 dated 31.03.2021 further approved by Nigam's Order & A&FS by Nigam's order No. RVPN/DS/GAD/F.3/Norms of Vehicle/D.727 dated 22.02.2022 & RVPN/DS/GAD/F. Norms of Vehicle/D.118 dated 10.05.2018 as per details given below-


The rates as per this circular are as follows:-

1. For first 1500 Kms or less, 26,400/- per month (GST extra, if applicable).
2. For additional running of vehicle (more than 1500 Kms) the rate payable @ Rs.10.00 per Km.
3. Hired vehicle shall be used anywhere as per jurisdiction of RVPN. In case of night halt other than that of head quarter a sum Rs. 300/- per night shall be paid for the driver.

4. The maximum ceiling of Rs. 28,500/- per month (GST extra, if applicable will be borne by RVPN) for 2000 Kms for offices having jurisdiction of one district.
5. The maximum ceiling of Rs. 30,300/- per month (GST extra, if applicable will be borne by RVPN) for 2200 Kms for offices having their jurisdiction of more than one district but less than the whole state.
6. The maximum ceiling of Rs. 33,000/- per month (GST extra, if applicable) for 2500 Kms for official use in respect of those offices whose functional and operational jurisdiction is spreading over the entire state.
7. All taxes except toll tax & GST shall be borne by the individual/contractor/firm. Reimbursement of toll tax paid by the individual/contractor/firm shall be made on production of receipt of payment of toll tax. GST will be applicable as per circular No. RVPN/CAO(P&C)/AO(P&C-II)/D.1770 dated 28.01.2020 of Chief Accounts Officer (P&C), RVPN, Jaipur.
8. If any revision issued by the finance department and subsequently adopted by RVPN the revised rates will be applicable.
9. The period of Hiring of vehicle may be increased or decreased as per requirement.

Other conditions shall be as under:

1. Vehicle with taxi permit having valid documents shall be considered.
2. Vehicle shall not be more than 6 years old. In case the vehicle is more than 6 year old and the condition of the vehicle is satisfactory, a relaxation of not more than 2 years (i.e. vehicle should not be more than 8 years old). Only vehicles with taxi permit having valid documents shall be considered.
3. The vehicle is to be hired from 01.04.2022 to 31.03.2023 (12 months). Bill is to submitted monthly and payment shall be arranged on monthly basis.
4. The consent is being invited by Superintending Engineer (Communication) Rajasthan Rajya Vidyut Prasaran Nigam Limited, having office at 220 KV GSS Heerapura, Jaipur or the Name of respective office/ location where hired vehicle is required and consent is to be sent on aforementioned address. Email id is se.comm.jaipur@rvpn.co.in .
5. Consent is to be received latest by 5.00 PM on dated 10.03.2022.
6. Vehicle owner and driver must be the same person, otherwise owner shall get his driver registered under EPF and should submit EPF challan monthly alongwith the Bill.
