Terms and Condition:

A. Scope of Work

1. Repair of cards as given in the schedule of material and prices, shall be made in good working condition to the consignee.
2. Burnt, Warped, Physically damaged cards & cards with missing components which are beyond economical repair, shall not be accepted for repair. The cards will be sent back to RVPN.

B. Terms of Payment

1. The invoices shall be submitted in three copies in the name of Assistant Engineer (Comm), RVPN, Kota. 100% payment along-with taxes and duties will be released within 30 days on receipt of goods at site. The payment shall be made by AO (T&C) RVPN, Kota through RTGS/NIFT/ Electronic Transfer. The charges for transfer through RTGS/ NIFT shall be on the parts of supplier.

2. Taxes to be reimbursed extra as per the rates applicable at the time of billing during currency of the order. Presently GST @ 18.0% is applicable. During currency of repair order if any new tax or duty is levied or revised by Government of India / State Government the same will become integral part of the repair order.
3. In case of delay in payment, the purchaser shall not be liable to pay any interest on the outstanding amount to the supplier.
4. Unit Repair price includes fault finding, replacement of components (except PCB), testing of cards only & Freight & Packing charges.

C. Delivery

1. The faulty cards shall be repaired within 45 working days after receipt in PUNCOM. The postage / delivery period shall be extra from the repairing time.
2. PUNCOM will pack and dispatch the repaired cards to this office.

D. Consignee:

Repaired cards should be delivered to Assistant Engineer (Comm), RVPN Kota.

E. Manufacturer's Warranty


Warranty period of repaired cards shall be three months from the date of receipt at site. Damage to the repaired cards due to improper handling by site officials such as physical damage to the repaired cards /repairing at site shall be treated as new work order for repairs.

F. Jurisdiction of Courts

All disputes difference and questions whatsoever arising between the purchaser and supplier upon or in relation to or in connection with the contract shall always be deemed to have arisen in Rajasthan and no other courts except the courts in Rajasthan shall have the jurisdiction to entertain the same.


G. Acceptance of Order
