The rates for hiring of Vehicle as per finance Department GOR Circular will be as under:-

1. For first 1500 Km. or less, Rs. 20000/- per month with driver, POL and R&M of Vehicle etc. (Service Tax extra if applicable)
2. For additional running of Vehicle (more than 1500 Km.) the rates payable @7.25 per Km.
3. The Maximum ceiling is Rs. 25075/- per month for 2200 Km. for office having jurisdiction of more than one district.
4. Hired vehicle shall be used anywhere as per jurisdiction of the office where deployed. In case of night halt other than that of head quarter a sum of Rs. 200/- shall be paid of the driver.
5. All taxes except toll tax/ parking charges shall be borne by the individual/contractor/firm.
6. Reimbursement of toll tax paid by the individual/contractor /firm shall be made on production of receipt of payment of toll tax.

Other Conditions shall be as under:-

1. Vehicle shall not be more than 6 Year old. Only vehicle with taxi permit having valid document shall be considered.
2. All types of liabilities of Vehicle will be borne by the contractor/service provider/individual e.g. taxi permit, insurance, fitness, registration, pollution certificated etc.
3. The rates /prices are inclusive of all taxes, duties, R&M charges of vehicle, contribution to CPF/EPF, ESI & other liabilities except any taxes if applicable.
4. Income tax & other taxes will be deducted at source by the Nigam.
5. Bill to be submitted on monthly basis and after verification of AEN (Commn.) RVPNL, Ajmer, the payment shall be Accounts Officer (T&C) RVPNL, Ajmer.
6.
