

The rates as per this circular are as follows:

1. For first 1500 KMs or less, 20,000/- per month (service tax extra if applicable).
2. For additional running of vehicle (more than 1500 KMs) the rate payable @ Rs. 7.25 per Km.
3. Hired vehicles shall be used anywhere as per jurisdiction of the office where deployed. In case of night halt other than that of head quarter a sum of Rs. 200 per night shall be paid for the driver.
4. The maximum ceiling of Rs. 27,250/-/- per month (service tax extra if applicable) for 2500 KMs for offices having jurisdiction of the entire state .
5. All taxes except toll tax shall be borne by the individual/ contractor/firm.
Reimbursement of toll tax paid by the individual/ contractor/firm shall be made on production of receipt of payment of toll tax.

Other conditions shall be as under :

1. Vehicle shall not be more than 6 years old. Only vehicles with taxi permit having valid documents shall be considered
2. The vehicle is to be hired from date of agreement to 31.03.2017 . Bill is to be submitted monthly and payment shall be arranged on monthly basis.
3. The consent is being invited by Addl.
