- a) Technical Bids in sealed envelope, complete in all respect, shall be submitted:
- To the address in Para 4 above. However, the Bidder shall not submit Financial Bid in hard copy (i.e. Financial Quote is to be uploaded on <http://eproc.rajasthan.gov.in> portal along with the technical bid).
 - On or before 15 November 2018 (up to 18:00 Hrs. IST).
 - Bidders shall also submit the following in hard copies:
 - (i) A non-refundable Bid Document Fee of INR 5,000+ GST @18% = INR 5,900 or USD 72+GST @18% in the form of Demand Draft or Bankers Cheque payable at Jaipur in favor of "Accounts Officer (P&C-I), RVPN, Jaipur", if downloaded from websites.
 - (ii) A non-refundable Processing Fee of INR 1,000 (in case of notification issued by RSIL applicable GST shall also be payable by the bidder) in the form of Demand Draft or Bankers Cheque in favor of "MD RISL" payable at Jaipur.
 - (iii) The Bid security INR 0.46 Million or USD 6562 shall be deposited by the Bidder through Demand Draft / Banker's Cheque payable in favour of Accounts Officer (P&C-I), RVPN, Jaipur or through Bank Guarantee in prescribed format in favour of Chief Engineer (Contracts), RVPN, Jaipur.
