
OTHER TERMS & CONDITIONS OF CONTRACT - ANNEXURE -A

(1) SCOPE OF SERVICE/Technical specification

The scope and nature of services to be provided by the contractor shall include scheduled preventive maintenance services which cover periodic and break down servicing, along with replacement of defective spare parts, including compressor and its parts and other consumables, if required during the contract period. The rate quoted for services shall also include the charges for deputing manpower if required. The routine maintenance service which shall include at least the following services:

Checking and servicing of the AC unit four times in a year & de-scaling of units if required, which includes:

- I. Replacement of Filter.
- II. Checking operation of controls of the air- conditioners such as thermostat, relays, remote control etc.
- III. Checking air flow through the supply air grill, return air grill, condenser
- IV. Checking operation of the drive motors and fans
- V. Checking air temperature at supply air grill, return air grill, Inlet air condenser, outlet air from condenser
- VI. Checking Firmness of supporting arrangement for the compressor, blower motor, air conditioners casing and fixing of air-conditioners etc. Anti-rusting Painting of the MS portion prone to rusting
- VII. Replacement of any component of air conditioners found defective after the above checks and tests.
- VIII. Cleaning the condenser and evaporator coils with suitable detergent /chemical solution and flushing with high pressure jet of water.
- IX. Greasing of blower motors and all moving parts.
- X. **Periodical checking & preventing service of the indoor & out door units four time in a year to undertake the service & maintenance room air condition in good condition for a year .Service report duly filled and signed by signed by the RVPN officer in charge shall be submitted on quarterly basis for retain of payment.**
- XI. **ATTENDING COMPLAINTS.**
 - a. The contractor shall provide services of an expert Mechanic & helper having knowledge and experience in the operation & maintenance of the AC units.
 - b. Supply free of charges, of all the spares and materials which are needed for the unit as a result of air wear & tear including consumables, defective items and necessary for the unit and voltage stabilizer .



- c. The servicing and maintenance shall be carried out without disturbing the normal functioning of the office, The filters shall be cleaned on weekly basis and record thereof shall be maintained.
- d. The history sheet of servicing /breakdown repairing of each and every unit shall be maintained & verified by AEN (MIS & IT), RVPN, JAIPUR.

(2) DURATION OF CONTRACT

The contract would be initially for a period of 12 months from the date of commencement of work order. It can be extended further on the same terms and conditions, with mutual agreement & RVPN and firm.

The contractor is also required to work on holidays in case of need for which no extra payment shall be made. Daily attendance and complaint register must be maintained and will be produced before the office / in charge of work.

(3) UNSATISFACTORY PERFORMANCE

If the performance of the contractor is not satisfactory and he fails to attend the complaints in time as stipulated in the tender, fails to attend the complaint to any of the works as contained in the scope of work, recovery from his bills will be made. The decision of the RVPN in respect of the magnitude of non-performance and its recovery thereof shall be binding on the contractor.

The contractor shall be responsible for the acts and deeds of its staff. RVPN will in no way be responsible for violation of any applicable law, rules and / or other loss caused either by the contractor or its staff.

RVPN reserves its right to recover from periodical payments to be made to the Contractor, any loss or damage that may be caused to the equipment, machinery, building or any other property of RVPN by negligence or any other reason whatsoever by the Contractor.

2.Working Hours: The normal working hours for various AMC works

3. Total estimated cost : The total estimated cost of AMC of Split AC work of IT Centre , Chambal Power House for one year is Rs. 37734/- (Rupees Thirty Seven Thousand Seven Hundred & Thirty Four only) including Labor & all materials, equipment's required for this work including all taxes.

4. Performance Security:

(a).In order to secure/assure the due fulfillment of the contract, the firm shall have to deposit the performance security amount equivalent to **10%** (ten Per cent) of the amount of work order. 


